COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor McGavick congratulated John Briehl and his staff for the Dr. Martin Luther King Celebration held at the Tacoma Dome. She also thanked Mayor Baarsma for his participation.

Council Member Lonergan expressed concern for the possible closure of Pioneer Chlor Alkali and stated the Public Utility Board, Council, and staff were working hard to resolve issues.

Council Member Lonergan paid tribute to local businesses. He stated the *News Tribune* has increased in circulation. He noted at an airport that there were tins of mints with picture postcards of Washington State on them, which were made by Brown and Haley, Tacoma, Washington; distributed by Smith Western Postcards and Novelties, Tacoma, Washington.

Mayor Baarsma thanked John Briehl and staff for putting on the largest event of its kind with over 3,000 people in attendance for the Dr. Martin Luther King Celebration. He stated the keynote speaker was the Reverend Dr. Leslie Braxton.

Mayor Baarsma stated he represented the City at a meeting, held at the Washington State History Museum, sponsored by the State Labor Council, to celebrate the 100th Anniversary of the formation of the American Federation of Labor in Washington State; and to celebrate the Woody Guthrie Exhibit which ended last Monday.

Deputy Mayor McGavick moved to convene to Executive Session to discuss labor negotiations, the session not to exceed 30 minutes. Seconded by Council Member Moss. Voice vote was taken and carried. The motion was declared adopted.
