Resolution No. 35803

Resolution No. 35806

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. commented on the recent symposium sponsored by the International City/County Management Association relating to performance measurements and best practices. He stated Ms. Diane Supler, Office of Management, Budget, and Analysis Director, is heading a technical team made up of various departments to create good performance measurements to provide for Council review later this year.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor Moss moved to excuse Council Member Phelps from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Council Member Evans stated he, other City staff, and Mayor Baarsma attended the Sister Cities International (SCI) state conference. He stated that 15 of the 60 in attendance were from Tacoma. He stated the City gave a report on the Film Festival and the model was then taken back to Washington D.C., by the Assistant Director of SCI, to present to the United States cities in the SCI organization (approximately 800). He added that Tacoma has a standing at the national level in the program for international understanding and citizens interconnecting throughout the world.

Council Member Lonergan announced that the Jr. Daffodil Parade will take place in the Proctor District on Saturday, April 5, 2003, at 10:00 a.m. He recognized the Public Works Department for their outstanding response time to a customer's concern relating to ruts in an alley.

Council Member McGavick requested a report on what the Sister Cities have done for the City of Tacoma.

Deputy Mayor Moss stated she represented Mayor Baarsma at the Cambodian New Year festival event, on Saturday, at the Tacoma Dome. She stated that the attendance exceeded years past and that it was a wonderful event.

Mayor Baarsma thanked Deputy Mayor Moss for representing him at the dedication ceremony for public art in the Dome District. He stated that the American Association of the State Department of Transportation Standing Committee held their yearly meeting in Tacoma recently and that he was given the opportunity to invite the Committee back to Tacoma to ride the light rail in 2005. He also thanked Council Member Miller for his involvement in bringing the Committee to Tacoma.
