## FIRST READING OF ORDINANCES

#### Ordinance No. 26834

Amending Chapter 13.06 of the Municipal Code to reclassify the property located between South 56<sup>th</sup> and South 64<sup>th</sup> Streets, bound on the east by Tacoma Mall Boulevard and on the west by South Wapato Street, from an "R-3-PRD" Two-Family Planned Residential Development District and "C-P-C" Planned Community Shopping Center District to an "R-2" One-Family Dwelling District to allow the zoning to be consistent with the low-intensity comprehensive plan designation of the site. (City of Tacoma; File No. REZ2001-00003)

Deputy Mayor Phelps moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner. Seconded by Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

#### Ordinance No. 26835

Vacating the east 20 feet of West Union Avenue between South 17<sup>th</sup> and South 18<sup>th</sup> Streets (High Five, L.L.C.; File No. 124.1122) and West Union Avenue between South 18<sup>th</sup> and South 17<sup>th</sup> Streets (Chaffey Homes, Inc.; File No. 124.1143) for commercial development.

Amending the Asarco Tacoma Smelter Redevelopment Definitive Agreement, dated September 25, 1996, to add residential use as an appropriate additional element of post-remediation site development; revise the Definitive Agreement, the Master Development Plan, and the Environmental Impact Statement; create a Site Development Authority (SDA) to carry out the amended Master Development Plan; amend Section 8.6 of the Definitive Agreement to permit use of Public Development Authority funds to be used by the SDA for activities, improvements, costs, and expenses associated with development of the site; and appoint Council Member Doug Miller as the City's representative to the Site Development Authority.
