Amending Chapter 13.06 of the Municipal Code to reclassify the property located approximately 300 feet south of South 19th Street between Washington Street and West Union Avenue, from a "R-2" One-Family Dwelling District to a "R-4L" Low Density Multiple-Family Dwelling District to allow for a 12-unit apartment complex. Ordinance No. 25786

Accepting a grant from the Washington State Department of Ecology, in the amount of \$533,833, depositing in and appropriating said sum from the Waterfront Acquisition Summary Fund for remediation of the Morris property along the Thea Foss Waterway.

Ordinance No. 25787

Accepting a grant from the Washington State University, in the amount of \$1,000, depositing in and appropriating said sum from the Sanitary Sewer Utility Fund for TAGRO Mix Demonstration Kits to be used in public schools.

Council Member Miller moved to remove Resolution No. 33201 from the agenda. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Resolution No. 33201 was removed from the agenda.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Deputy Mayor Evans commented on the Public Utilities land trade meeting he attended on behalf of Mayor Moss on Saturday. He reported that the City gained 1,000 acres of property within a half mile of the Green River Watershed.

Council Member Silas reminded citizens to exercise their right and vote tonight.

Council Member Baarsma announced that the Mayor of Hachinohe, Japan will be meeting with representatives from the Port of Tacoma later this month to enter into an agreement between the Port of Hachinohe and the Port of Tacoma. Council Member Baarsma thanked Juli Wilkerson for providing a list of projects that would be effected by the 5 percent increase in CDBG set asides for housing.

Council Member Miller reported that the courts have overruled the County Council on their designations of rural activity centers, which is what is identified around the Tacoma Narrows Airport. He indicated that the County is in the process of identifying a more rural designation and he expressed concern that the City's potential for the airport may be eliminated unless the City takes action quickly to communicate to the County Council that the City cannot allow this to happen. Council Member Miller indicated that he will not be attending next week's Council meeting.

Mayor Moss indicated that he sent letters to Rabi Rosenthal and and Sister City Kiryat, Motzkin expressing the sorrow on the loss of Prime Minister Y. Rabin.

Council Member McGavick congratulated Alice Bush for her new position as City Clerk of Lakewood.

Council Member Miller moved to recess until 6:00 p.m. Seconded by Mayor Moss. Voice vote was taken and carried. The motion was declared adopted. The Council recessed at 5:45 p.m. and reconvened at 6:05 p.m.
