COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Council Member Hyde reported on the conference he attended in Washington, D.C. last week, held by the National League of Cities, and stated that the news in regard to revenue sharing funds does not look good.

Council Member Bichsel said she got the impression that Congress is willing to phase out federal revenue sharing funds over a two-year period.

Deputy Mayor Strege said there was a citizen complaint regarding SONG'S ADDITION and that the roadway was not the 32 feet that the City normally requires. He requested staff to check into this matter and get a response back to the Council.

Deputy Mayor Strege said he had a suggestion from the Landmarks Preservation Commission in regard to historic districts and structures and preventing demolition to same by reason of neglect. He asked staff to check into laws the City and State have regarding comparable demolition by neglect ordinances and report back to the Council.

Deputy Mayor Strege moved to recess to Executive Session to discuss litigation and real estate. Seconded by Council Member Hyde. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 7:06 p.m. and reconvened at 7:35 p.m.

Council Member Stenger made the following motion:

I hereby move, based upon the request of the City Attorney, that the proper officers of the City of Tacoma are hereby authorized and directed to approve a settlement in the lawsuit filed by James A. Knutsen and Jeanine R. Knutsen, husband and wife, against the City of Tacoma, and others, under Pierce County Cause No. 84 2 00158 1; that the proper officers of the City of Tacoma are hereby authorized and directed to approve the settlement of this suit, the lawsuit being dismissed with prejudice, and the City of Tacoma paying to the plaintiffs the sum of \$35,000.00, plus costs in the amount of \$306.81. The City of Tacoma will also provide that the plaintiff, James A. Knutsen, be retained in his present position, and that no malice or prejudice arising from this lawsuit be directed toward or against him in any way, and that he will be retained in his current status and compensation.
