This is the date set for hearing the appeal of Frederick William Holt regarding the recommendations of the Hearings Examiner on his request for reconsideration relative to variance applications for a deck and bay window.

Hearings Examiner, Robert Backstein, made a presentation regarding the appeal.

Mr. Dwight Williams, attorney representing Frederick William Holt, presented the reasons for the appeal.

Mr. Otto Matsch, attorney representing Joseph and Margaret Englet, made a presentation in support of the Hearings Examiner's decision.

Councilman Rasmussen moved to concur in the Findings, Conclusions, and Recommendations of the Hearings Examiner with respect to the deck, but not the bay window. Seconded by Councilman Hawkins.

After further discussion and modifications, Councilman Rasmussen moved to not concur with the Findings, Conclusions, and Recommendations of the Hearings Examiner regarding the bay window, and: to grant the variance; to permit a variance in regard to the fireplace; to deny the variance for the deck; to not allow Mr. Holt to avoid payment of the permit fee and inspection of these two structures; and, further, that the fee be paid and the structures be inspected. Seconded by Councilman Hyde.

Roll call vote was taken, resulting as follows: Ayes: 5 - Hawkins, Kirby, Rasmussen, Strege, and Deputy Mayor Nielsen. Nays: 3 - Bichsel, Hyde, and Ladenburg. Absent: 1 - Mayor Sutherland. The motion was declared adopted.

Councilman Hyde requested that the Legal Department investigate whether there are grounds for proceeding on the violation of the ordinance involved.
