Ordinance No. 27298

FIRST READING OF ORDINANCES

Ordinance No. 27299

Amending Chapter 12.10 of the Municipal Code, relating to water regulations and rates, to implement a system average increase of 12.4 percent in two steps beginning January 1, 2005, through December 31, 2006, to meet projected costs of operation and maintenance, debt service, and mandated programs.

The Ordinance was set over for final reading next week.

Ordinance No. 27300

Amending Chapter 13.11 of the Municipal Code, relating to critical areas preservation, to ensure adequate protection of critical resources while permanent regulations are drafted and adopted.

The Ordinance was set over for final reading next week.

Ordinance No. 27301

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation for represented and unrepresented employees and changes in classification to reflect the organizational structure.

The Ordinance was set over for final reading next week.

Ordinance No. 27302

Approving the 2005-2010 Capital Facilities Program and amending the Comprehensive Plan.

The Ordinance was continued to the meeting of December 7, 2004, earlier in this meeting.

Ordinance No. 27303

Adopting the 2005-2006 Biennial Budget.

The Ordinance was set over for final reading on December 14, 2004.

RESOLUTIONS

Purchase Resolution No. 36353

Awarding contracts to:

1. James G. Murphy, Inc., in the amount of \$40,000, including sales tax, to renew and increase its contract to a cumulative total of \$76,000, for auctioneer services



for surplus vehicles and equipment through September 14, 2005 – Pierce County Contract 15643; and

2. Pacific Coast Truck Center, in the amount of \$245,000, plus sales tax, for three 2005 International cab and chassis – Washington State Contract No. 07503.

Deputy Mayor Evans moved that the Purchase Resolution be adopted. Seconded by Council Member Phelps.

Voice vote was taken and carried on the Purchase Resolution. The Purchase Resolution was declared adopted.

Resolution No. 36354

Adopting the document entitled "City of Tacoma 2005 Legislative Priorities."

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36355

Authorizing the execution of an agreement with Robert E. Mack, in the amount of \$70,000, plus 10 percent for expenses, for legislative liaison services from January 1, 2005, through December 31, 2005.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Mayor Baarsma. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36356

Authorizing the execution of an amendment to the agreement with Simon and Company, in the amount of \$35,000, plus \$2,500 for expenses, for congressional liaison services from January 1, 2005, through December 31, 2005.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36357

Authorizing the execution of a Quitclaim Deed to Pierce County for the sale of a portion of Tacoma Water property east of Canyon Road between 160th and 176th Streets to widen the intersection at Canyon Road and 176th Street.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36358

Authorizing the execution of an agreement and subsequent deed with Hawthorne Hill Condominium, LLC, in the amount of \$2,250 in cash and construction of an observation tower on the roof of the condominium building to be used by the Tacoma Police Department, in exchange for 3,272 square feet of City-owned real property at 320 East 32nd Street.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36359

Accepting \$33,453 from the Office of Crime Victim Advocacy of the State of Washington, Department of Community, Trade, and Economic Development, to allow 200 law enforcement officers within Pierce County to attend training for the investigation of domestic violence and special assaults.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36360

Authorizing the execution of a Collective Bargaining Agreement with the Joint Labor Committee, for the continuation of employee benefits, effective January 1, 2004, through December 31, 2006.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Mayor Baarsma.

Roll call vote was requested and taken, resulting as follows:

Resolution No. 36361

Authorizing the execution of a Collective Bargaining Agreement negotiated with District Lodge No. 160, on behalf of Local Lodge No. 297 of the International Association of Machinists and Aerospace Workers, Wastewater Treatment Plant Supervisors, which currently covers three employees, effective through December 31, 2006.



Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36362

Authorizing the execution of Amendment No. 3 to the agreement with Gregory J. Murphy, in the amount of \$15,000, for a cumulative total of \$65,000, for legal services during the review and analysis process of the Washington State Patrol Administrative Investigation report.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Council convened to Executive Session at 9:28 p.m. At 9:56 p.m. the Executive Session was extended an additional 15 minutes. The Council reconvened at 10:07 p.m.

Council Member Lonergan moved to excuse Council Member Talbert from tonight's meeting. Seconded by Council Member Ladenburg. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Evans moved to authorize the City's full and final settlement of all claims against the City in the case of <u>Frederick Bellows v. City of Tacoma, Belt Line Division, United States District Court, Cause No. C03-5278 RBL</u>, upon payment by the City in the amount of \$700,000.00. Seconded by Council Member Ladenburg. Voice vote was taken and carried. The motion was declared adopted.
