Councilman Strege inquired as to the procedure for increasing the minimum lot size. City Manager Erling Mork indicated he would investigate.

Mayor Parker, marking his first anniversary as Mayor, reported on the City Gouncil's accomplishments during the year 1978, and complimented them on their willingness to move ahead on some issues and the many difficult decisions they were required to make. He also complimented the City administrative officials for their far sighted vision in solving certain problems and for preparing for future development of the City. He reviewed the problems facing the City and the new projects he will be proposing for the year 1979.

Councilman Kirby referred to a resolution for expansion of the airport he understood was scheduled for the Council Agenda of the 23rd and asked that it be delayed until the 30th when a full Council will be present.

Mayor Parker asked the City Manager to schedule the resolution for January 30th.

Mayor Parker asked to be excused from attending next week's meeting. Councilman Schroeder moved that the request be granted. Seconded by Councilman Nielsen. Voice vote was taken and carried.
