CITIZENS' FORUM (BEGAN AT 6:02 P.M.)

Citizens' Forum was held earlier in the meeting.

UNFINISHED BUSINESS

Council Member De Forrest moved to reconsider the vote on Substitute Ordinance No. 26345 relating to the compensation plan. Seconded by Council Member Baarsma.

Roll call vote was taken, resulting as follows:

- Ayes: 2 De Forrest and Baarsma
- Nays: 7 Crowley, Kirby, McGavick, Miller, Phelps, Silas, and Mayor Ebersole

The motion to reconsider Ordinance No. 26345 was declared failed.

REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. introduced Lieutenant Catherine Woodard, Police Department, as the new Special Assistant in the City Manager's Office for the next three months.

Mr. Corpuz then stated that Mr. Len Simon, the City of Tacoma's congressional liaison from Washington D. C., would be in Tacoma next Monday and Tuesday, January 11-12, 1999. He stated that if any member of the City Council would like to discuss specific matters with Mr. Simon to let him know.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Baarsma stated that he, Elton Gatewood, Marion Weed, and Barbara Grout recently represented the City of Tacoma in Washington D.C. He stated that they also had the All America City Award with them.

Council Member Baarsma stated that he had the opportunity to meet with John Horsley, Deputy Assistant Director of the Bureau of Competition, Deputy Assistant to the Secretary of the Department of Transportation, to discuss City and Pierce Transit issues. He stated that he also met with Len Simon's staff and some leaders of the National Civic League, the Mayors of New Haven, CT; Toledo, OH; and some Council Members from Rochester, NY and Riverside, CA. Council Member Baarsma then stated that he met Congresswoman Lois Capps from California along with a Council Member from Santa Maria, California, who graduated from Pacific Lutheran University. He stated that she extended her best wishes to the people of Tacoma. He stated that he met Vice President Gore on Tuesday and extended Mayor Ebersole's regards. He stated that after meeting with the Vice President, the elected officials met with Mickey Ibarra, Assistant to the President and Director of Intergovernmental Affairs, and Lynn Cutler, Deputy Assistant to the President and Deputy Director of Intergovernmental Affairs, who extended her regards to Mayor Ebersole. He then met with Congressmen Norm Dicks' and Adam Smith's staff to discuss the empowerment zone funding. Council Member Baarsma pointed out that the City of Tacoma had taken a leap in faith with its economic development package with the job credits and the reduction in the tax to encourage economic development. He stated that it is his hope that Congressmen Dicks and Smith would convey that commitment.

Council Member Phelps stated that last year the Marymac Apartment fire in the Stadium District displaced over 40 families and the American Red Cross spent close to their entire year's budget helping those families relocate. He stated that the American Red Cross has asked him to chair a fund-raiser on January 19, 1999, called "Dine Out for Disaster." He stated that the fund-raiser is designed to replenish those funds which go to support families that are burned out and need relocation help. Council Member Phelps stated that there would be about 12 restaurants in the Tacoma area and one in Fife which have agreed to donate 15 percent of the day's total food and beverage sales to the American Red Cross. He stated that the *Tacoma Reporter* and *The News Tribune* would be running articles indicating which restaurants are participating. He then encouraged the City Council to buy a meal on Tuesday, January 19, for a great cause and a good organization.

Council Member McGavick stated that she has been receiving letters about the issue of housing rental registration that is in the discussion phase. She stated that she has some concerns about this issue and that she agrees with the citizens she has heard from that this may be another bureaucratic process of registration like the home-based business. She then inquired as to whether or not the City of Tacoma will be able to monitor it, police it, or control it. Council Member McGavick stated that she understands the intent of the Ordinance is to try to make it easier to get in contact with the people, who are owners of property within the City of Tacoma, who live outside the City of Tacoma. Council Member McGavick then asked that this issue be reviewed.

Council Member McGavick stated that the City Council received a letter from Len Simon, the City of Tacoma's lobbyist in Washington D.C., stating there may be some money for police officers and schools. She stated that this is an opportunity to write and submit grants which have deadlines of February 5, April 2, and June 4. She stated that it looks like a good concept the federal government is putting in place and maybe it would help the D.A.R.E. program. Council Member Silas stated that she was saddened last week to hear the news of the shooting that happened in the Hilltop area. She asked Police Chief Hairston to give an update of the incident.

Police Chief Hairston responded it was too soon to discuss the incident and indicated that he would give an update as soon as possible.

Council Member Silas inquired about having sign language interpreters at the City Council meetings at least once a month.

City Manager Corpuz stated that he would could check on that.

Council Member Miller echoed Council Member McGavick's concern over the housing rental registration. He stated that he thinks trying to enlist all properties is the wrong way to deal with this problem. He stated that the City of Tacoma needs to look at how we can significantly and severely punish those that are not keeping up their end of the bargain in providing housing which is a contributory to the City, rather than trying to punish all housing. He stated that the City Council received a letter that references a study which the City of Tacoma conducted in 1993 that showed 96 percent of property owners lived within King or Pierce Counties and that 93 percent of properties were maintained well and had performed continued repairs. He stated that he would like to have a copy of that study. He stated that he would like staff to be creative in how we go after offenders and not the populace.

Council Member Crowley complimented Tennessee in becoming national champions.
