Emily Miskovsky, member of the Committee, representing the League of Women Voters, read a prepared statement of the League which, in summary, asked that the needs of all sectors of the community be considered and parts of the shoreline be kept available for public use.

### CITIZENS REQUESTS TO BE HEARD:

 a. Mr. Elmer J. Church, President, Pierce County Homes for our Developmentally Disabled Person, Inc., wishing to present their program.

Mr. Elmer Church addressed the Council. He in turn introduced Mrs. Maxime Tolle, who made a detailed presentation to the Council requesting assistance in seeking funding for a group home in Tacoma for mentally retarded persons.

Following a brief discussion, Mr. Nielsen moved that the Tacoma City Council express its intent to study the possibility of co-sponsoring a group home situation with the Pierce County Homes for Developmentally Disabled People, Inc. for the purpose of allowing additional time for study and to allow for a route to continue to keep the application active for the Referendum 29 monies. Seconded by Mr. Nelson. Voice vote was taken and carried.

b. Citizen's Committee for Leasie Lang wishing to speak regarding the case of Leasie Lang.

Deputy Mayor Warnick then recognized Robert Gallucci, a co-chairman for the Citizens Committee for Leasie Lang. Mr. Gallucci briefly outlined the plight of Mrs. Lang and the condition of her current home. He requested City assistance to help resolve her problem. Such participation will include the appointment at this meeting of two City Council members to serve on the Committee. It is further understood that the school board has indicated that the board will serve as the lead and administrative support agency." Seconded by Mrs. Bichael. Voice vote was taken and carried.

Deputy Mayor Warnick then appointed Mr. Sonntag and Mr. Strege to the Joint Municipal Action Service Committee.

Mr. Sonntag then made a motion for the Council to adjourn into Executive Session for the purpose of discussing current labor negotiations. Seconded by Mr. Nelson. Voice vote was taken and carried. Deputy Mayor Warnick receased the meeting at 9:55 p.m.

Deputy Mayor Warnick reconvened the meeting at 10:22 p.m. and upon proper motion, the meeting adjourned at 10:23 p.m.
