COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Kirby advised that a Bill had been introduced in the State Legislature which would exempt the City from paying sales tax on the construction of the Sports/Convention Center. The exemption could amount to as much as \$1,500,000.

Councilman Hyde reported that the Fiscal Management Committee is working on the Park District problems and that Wednesday, the 28th, will be their third meeting. He also reported he is working with the Fourth of July Committee, They are anticipating solving some of the problems prior to the last minute. The plan is well underway.

Mayor Parker asked Mr. Sullivan, the Hearings Examiner, for a report on the conditions set on the rezone of the Tacoma Mall, particularly with regard to a pedestrian pass across 47th Street. Mr. Sullivan advised he would have Mr. Backstein do this since he was the one who prepared the report and conditions.

Mayor Parker said that on Friday, January 30, 1981, he is going to issue a special proclamation declaring that day in honor of Catherine Ursich, Deputy City Clerk, who is serving as Clerk for the Council for the last time tonight after many years of service for many Councils. She will be retiring from City service on Friday.
