# **REPORTS BY CITY MANAGER**

After discussion, Council Member Miller moved to authorize the City Manager to grant a three-month waiver of residency for G. Kenneth Tross for the position of Sewer Maintenance Division Manager. Seconded by Deputy Mayor Crowley. Voice vote was taken and carried with Council Member De Forrest voting in opposition. The motion was declared adopted.

# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Mayor Ebersole commended Allen Correll, Human Rights Director, and his staff for the fantastic celebration of the life of Dr. Martin Luther King, Jr. at the Tacoma Dome on Monday, January 19, 1998. He stated that it was one of the largest gatherings in the nation.

Council Member Phelps stated that he has received a number of complaints concerning the damage caused by the increase of graffiti in the Sixth Avenue, Proctor and Stadium Districts. He asked the City Manager to look into the legality of setting up a reward fund, possibly in partnership with Safe Streets. Council Member Phelps stated that the reward fund program has been very successful in other cities. He stated that the City of Seattle has a program called "Graffiti Rangers." He stated that the "Graffiti Rangers" remove graffiti in an environmentally friendly manner, by not using caustic materials, and using recycled paints. He suggested that our staff use Municipal TV to promote a graffiti hotline.

Council Member Phelps acknowledged and congratulated the staff from Pierce Transit for putting together a program that will have commuter linking from the internodal center through downtown to a number of locations.

Council Member Silas commended the Human Rights Department for an excellent Martin Luther King, Jr. Celebration. She stated that each year it becomes bigger and better. She stated that the important thing to remember is the celebration of the birthday of Martin Luther King, Jr. and the diversity within our city.
