Mayor Ebersole stated that he went to Olympia today to check on the City's funding request in the capital budget. He stated that the University of Washington-Tacoma has been budgeted to receive approximately \$35 million, of which a half million dollars is going towards planning for Phase III. He stated they are hoping to increase that amount in the Senate. He stated that there was a half million dollars for the Dickman Mill site, which will help turn the site into a waterfront park. He stated that there was money for the Tacoma Art Museum construction and for the Glass Museum. He thanked Council Member Phelps for his attendance in Olympia on the Convention Center bill.
