# Resolution No. 24608

Authorizing application to the U.S. Dept. of Labor for a grant in the sum of \$1,391,331.00 for comprehensive employment and training services for eligible City residents.

Al Starr, Assistant Director of Comprehensive Employment, asked that the Resolution be continued for two weeks.

Mr. Nelson moved to continue the resolution for two weeks. Seconded by Mr. Strege. Voice vote was taken and carried. The Resolution was continued to Thursday, September 22, 1977.

# Resolution No. 24617

Authorizing the purchase of influenze vaccine from Wyeth Laboratories and Merck Sharp & Dohme and waiving the requirement for competitive bidding.

Mr. Hudson moved that the Resolution be adopted. Seconded by Mr. Schroeder. Voice vote was taken and carried. The Resolution was declared adopted.

### Resolution No. 24618

Approving the corridor recommended by the State Highway Department for SR 509.

They moved to adopt the revised Resolution No. 24618.

Mr. Warnick moved to amend Page 2, Line 22, to change the word "should" which follows the word design to read "shall". Seconded by Mr. Nielsen.

Roll call vote was taken on the motion, resulting as follows:

The motion was declared passed.

Voice vote was taken on the amended, revised Resolution and carried. The amended, revised Resolution was declared adopted.



# Resolution No. 24619

Authorizing preparation of plans and specifications and obtaining of bids for the construction of Puget Mini Park, a Community Development project.

Ron Button, Director of Public Works briefly reviewed the project as was discussed at the last Council Meeting. The project presented at that time was the compromise wherein the Big Toy play area was moved away from the corner of the park.

Speaking to the resolution were: Frederick B. Hayes, 3402 North 31st, who asked for a design change and presented a petition with 539 signatures; Laurie Johnson, 3912 North 31st; Natalie Baarsma, 3709 North Madison; Jim Caraher, 3601 North Union; Ruth Johnson, 3912 North 31st; Donna Hogaboam, 3714 North 38th.

After discussion Mr. Schroeder moved to adopt the plan as originally proposed with the play area up on the street level. Seconded by Mr. Warnick.

After further discussion Mr. Schroedernand Mr. Warnick withdrew their motion to yield to a motion to be made by Mayor Johnston.

Mayor Johnston moved to amend the resolution, the last paragraph, on line 17 after the word "directed" to insert the words "to retain professional consultants" and delete the rest of the paragraph and add the words "and specifications necessary to obtain construction bids for the Puget Mini Park in accordance with the original plans and program scope." Seconded by Mr. Strege. Voice vote was taken and carried.

Also speaking for the resolution were: Mr. Rolf Rollefson of 3734 North 31st and Mrs. Fred Mullen of 2117 North 29th Street.

Voice vote was taken on the resolution as amended and carried. The amended Resolution was declared adopted.

### Resolution No. 24621

Approving the final plat of Centennial Park Div. No. 2 in the vicinity of the northside of 33rd St. N.E. between 49th Avenue N. E. and 53rd Avenue N.E.

Mr. Nielsen moved that the Resolution be adopted. Seconded by Mrs. Bichsel. Voice vote was taken and carried. The Resolution was declared adopted.

### APPEALS:

This is the date set for hearing the appeal of Rovai, McGoffin, Turner & Mason, Attorneys at Law, for MBRM Investors, on the Hearings Examiner's decision to allow continued use of an off-street parking area in an "R-5-T" District and waiver of off-street parking area development standards to allow an existing parking area to remain

unpaved at the southwesterly corner of South 8th and Yakima Avenue. (Continued from the meeting of August 23rd)

Mr. Backstein reported that Attorney McGoffin has asked that this be continued for two weeks.

Mr. Hudson moved that the hearing on the appeal be continued for two weeks. Seconded by Mr. Nelson. Voice vote was taken and carried. The appeal was continued to Thursday, September 22, 1977.

# REPORTS BY CITY MANAGER:

Erling Mork, City Manager, introduced Lynnett Baugh, the newly appointed Director of the Office of Intergovernmental Affairs. He also asked approval of \$1,600 for moving expenses for her.

Mr. Hudson moved that the \$1,600 moving expenses be approved. Seconded by Mr. Schroeder. Voice vote was taken and carried.

Mr. Mork advised that Bob Hamilton, City Attorney, has a report. Mr. Hamilton advised Council of a claim for the wrongful conversion of an automobile by the Police Department, who was acting under a State statute which the Supreme Court held to be unconstitutional. The sum of the compromise is \$3,000 for full settlement of the claim. He also advised that concurrence in the settlement is recommended by the City Attorney's office.

Mayor Johnston moved to approve the settlement of the claim as presented. Seconded by Mr. Warnick. Voice vote was taken and carried.
