Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to implement rates of pay and compensation for employees represented by Tacoma Police Management Association, Local 26, which covers 21 employees, effective January 1, 2004, through December 31, 2004.

Ordinance No. 27319

Authorizing the execution of agreements with the Washington State Interagency Committee for Outdoor Recreation (IAC), for a total amount of \$1,340,000 in IAC grant funds for float, breakwater and boat ramp improvements at Point Defiance Park and authorizing the execution of an agreement in the amount of \$1,170,000 with Metro Parks Tacoma for purchase of the improvements by Parks upon completion; accepting the total sum of \$2,510,000 from the Washington State Interagency Committee for Outdoor Recreation and Metro Parks Tacoma and appropriating that sum for the Point Defiance Boat Ramp Expansion Project, and further authorizing the execution of an agreement in the amount of \$2,510,000 with Metro Parks Tacoma for the acquisition and installation by Parks of the float, breakwater, and boat ramp improvements.

Deputy Mayor Ladenburg moved to waive further reading of the Ordinance based on information provided. Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

Council Member Lonergan stated he preferred the Ordinance be read into the record since its reading was waived during First Reading. No Council Members voiced opposition to Council Member Lonergan's request.

FIRST READING OF ORDINANCES

Ordinance No. 27320

Amending Chapter 8.105 of the Municipal Code, relating to domestic violence, to make minor corrections to several sections.

The Ordinance was set over for final reading next week.

Ordinance No. 27321

Amending Chapter 13.17 of the Municipal Code, relating to Mixed-Use Center Development, to offset the costs of administration of the 10-year Property Tax Exemption program by increasing the fees for approved applications for up to four multi-family units to \$1,000, with an additional fee of \$100 per multi-family unit, up to a maximum fee of \$5,000, effective April 1, 2005.

Resolution No. 36438

Authorizing the execution of an agreement with NetVersant, in the amount of \$225,000, for cable installation at the new Police Department Headquarters.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36439

Declaring surplus certain land at Lake Kapowsin and approximately 46 acres in the upper Green River Watershed for the purpose of implementing the 1995 Agreement with the Muckleshoot Indian Tribe.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36440

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with New Urban Properties, LLC, to construct 52 condominium units located at 708 through 714 Market Street in the Downtown Mixed-Use Center.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36441

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with Catapult Development Partners, LLC, to construct 58 condominium units located at 728 through 740 Market Street in the Downtown Mixed-Use Center.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.



Resolution No. 36442

Requesting the Department of Corrections (DOC) to initiate strategies by Spring 2005 to promote the development of specialized offender programming in counties that currently benefit from services available exclusively in Pierce County; and further requesting the DOC support regional initiatives to improve systems and services targeting local high-needs, high-utilizer populations by implementing formal policies that re-align agency resources in the West Central Region to reflect the needs of the high-risk population under DOC supervision in the Pierce County Jail by Spring 2005.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

PUBLIC HEARING

This is the date set for a public hearing by the City Council on proposed amendments to Title 13 of the Municipal Code, "Land Use Regulatory Code," relating to adult uses, by adding "sexual encounter establishment" to the list of uses categorized and regulated as "adult uses," which specifies distribution and requirements for separation from sensitive areas such as parks, libraries, day care centers, religious facilities, schools, and residential zones.
