### COMMUNICATION

Hearing Examiner recommending approval of a request to modify a previously approved reclassification of the property located at 4701 South 19<sup>th</sup> Street to allow construction of a 19,100-square-foot addition onto the north end of an existing 17,114-square-foot office building, for a total office building size of 36,214 square feet. #### Ordinance No. 26959

Amending Chapter 1.12 of the Municipal Code to implement rates of pay and compensation for certain represented and unrepresented employees and changes in classification to reflect the organizational structure including the United Transportation Union (Switch Crews Unit) and the Brotherhood of Locomotive Engineers.

The Ordinance was set over for final reading next week.

#### Ordinance No. 26960

Authorizing the execution of grant agreements with the United States Department of Housing and Urban Development; depositing in and appropriating \$3,311,000 from the Community Development Block Grant Summary Fund for community development projects; depositing in and appropriating \$2,278,000 from the Miscellaneous Grants Summary Fund for HOME Investment Partnership projects; and depositing in and appropriating \$119,000 from the Miscellaneous Grants Summary Fund for Emergency Shelter Grant projects.

The Ordinance was set over for final reading next week.

### Ordinance No. 26962

Adopting the 2001-2002 Biennial Budget modifications; and appropriating funds for additional contract obligations, transfers, other budget adjustments, and additional estimated revenues; creating an operating fund for the new Convention Center; authorizing an interest-bearing interfund loan, in the amount of \$200,000, from the Endangered Species Fund to the BLUS Demolition Billing Fund; and appropriating \$2.5 million from the 1997 Bond Issue Construction Fund for construction of Fire Station No. 8.

### **REPORTS BY CITY MANAGER**

City Manager Ray E. Corpuz, Jr. congratulated Fred Yomes, Nancy Johnson, and staff of TV Tacoma for an award from the Alliance for Community Media which named TV Tacoma's Vision 2000 election coverage as this year's annual Hometown USA Award for best election coverage.

Mr. Corpuz stated Mark Crisson, Tacoma Public Utilities Director, will be receiving a Distinguished Citizen Award tomorrow, at the Municipal League Annual Luncheon, for his work in the community.

### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Moss stated on Sunday she presented a proclamation at the 75<sup>th</sup> Anniversary of the Matron's Club, which is the oldest women's federated club in Washington State. She stated the club's motto, "Lifting As We Climb," is indicative of what this group of women has done over these 75 years with young people, least of which is the yearly scholarship they provide.

Council Member Evans stated on Saturday he attended the dedication of Valerie's Park on North 8<sup>th</sup> and North K Streets, in honor of the late Valerie Sivinski, former City of Tacoma Historic Preservation Officer.

Council Member Talbert stated he received a letter regarding fundraising for the South End Pool, which still needs to raise approximately \$1 million to make it a state-of-the-art attraction for all of Tacoma. He stated there will be a fundraising meeting this Thursday, at 5 p.m., at the Mottet Library on East 35<sup>th</sup> and East G Streets.

Council Member Ladenburg stated there will be a groundbreaking for the South End Pool, on July 1, 2002, at 2 p.m. She stated people may call Nancy Davis, Metro Parks, at 305-1021, for information. Council Member Ladenburg stated that on Friday, June 14, 2002, there will be a ribbon cutting ceremony at the Fern Hill Square and invited interested parties to attend.

Council Member Phelps stated he has been asked to serve on the Mayor's Cup Committee to organize the second annual golf tournament. He stated this year's beneficiary will the Artists in Residence Program at Jason Lee. He stated applications have been sent and are expected to sell out early for this great charity event. He stated there are still some sponsorship opportunities available.

Council Member Lonergan congratulated Expedia.com, located on South 21<sup>st</sup> Street and Pacific Avenue, for the growth of their company, which does travel arrangements over the internet and telephone.

Council Member Moss encouraged people to visit the Hilltop and East Side neighborhoods, where many beautiful, older homes, and affordable housing are located.

Mayor Baarsma stated this past weekend he attended the State Democratic Party Convention in Bellingham where he lobbied to have them bring the convention to Tacoma in 2004, which is a presidential election year. He stated he had the commitment of the State Chair, Vice, Chair and Treasurer. He stated there is a lot of enthusiasm for this and that we just need to sell the idea to the State Committee. He then asked for assistance in lobbying the Republican Party.
