Approving the sale of a 90 square-foot parcel of surplus property located on the southeast corner of the Elk Plain Substation in Pierce County, to Pierce County for \$1,000.

Resolution No. 35819

Authorizing the execution of a Real Estate Purchase and Sale Agreement with Plum Creek Timberlands, L.P., in the amount of \$45,000, to purchase approximately 21.67 acres of property located adjacent to Green River Headworks Road in King County.

Deputy Mayor Moss moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 35820

Authorizing the execution of the 2003 Pierce County Enhanced 9-1-1 Primary System Answering Points Participation Agreement and receiving \$157,200 from Pierce County for emergency communication.

Deputy Mayor Moss moved that the Resolution be adopted. Seconded by Council Member McGavick. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 35821

Designating the sites at Kandle Park, Wapato Park, the Centre at Norpoint, and South 16th and Martin Luther King Jr. Way as the sites for the North, South, Northeast and Central police substations; authorizing the execution of a variety of agreements with the Tacoma School District No. 10, the Boys and Girls Clubs of South Puget Sound, the Metropolitan Park District, the Martin Luther King Housing Development Authority, June Reda, and Frank Miele to locate police substations at these locations.
