Elise Berg stated that she is deferring her speaking to three other members of her group.

Gary Hartloff, Ellen Fleming and Grant Pelesky spoke to the Council regarding this matter. Ms. Fleming presented a petition to the Council with regard to heavy metal concerts.

Council Member Mykland asked the City Manager to bring a resolution before the Council next week banning festival seating at the Dome.

This is date set for hearing the appeal of Raymond Hayes relative to the denial of his request for a six foot front yard variance and a 22 foot rear yard variance to allow construction of an addition to a single family home.

Council Member Warnick asked City Attorney, Bob Backstein, regarding his relationship with Mr. Seinfield, who has represented his firm and himself personally, if that was a problem on his sitting in on discussion.

Mr. Backstein advised Council Member Harnick that if Mr. Seinfield still represented him that it would be better if he didn't participate.

All members of the Council stated that they know Mr. Seinfield and all felt that this would not influence there making a decision in this case.

Authorizing the proper officers of the City of Tacoma to execute an agreement with the U.S. Department of Labor in the amount of \$50,000; providing for the deposit of said sum in the Miscellaneous Grants Summary Fund, authorizing the transfer of \$7,500 from the General Fund to the Miscellaneous Grants Summary Fund, and appropriating the sum of \$57,500, or so much thereof as may be necessary, from the Miscellaneous Grants Summary Fund, for the purpose of providing outreach case management, employment and transitional housing services to homeless veterans.

Mayor Sutherland moved to recess to Executive Session to discuss a personnel matter and litigation, the session not to exceed five minutes. Seconded by Council Member McElliott. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 7:20 p.m.

Council reconvened at 7:35 p.m.
