COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Strege moved that the City of Tacoma support the nomination of Councilman Hyde to the newly established Puget Sound Water of Quality Authority. Seconded by Mayor Sutherland. Voice vote was taken and carried. The motion was declared adopted.

Councilman Strege stated that he, Councilwoman Bichsel, and other members of the Pierce Transit Board and staff wished to recognize the Mayor's service and tenure on the Pierce Transit Authority by adopting Pierce Transit Resolution No. 83068 which was legally and unanimously adopted by the Board of Commissioners of Pierce Transit in appreciation of the service of Commissioner Doug Sutherland. Councilwoman Bichsel presented the commemorative copy of the Resolution to Mayor Sutherland.

Councilman Kirby requested that the City Manager contact Mr. John Fields in Washington, D.C. to investigate the status of legislation introduced into Congress that would prohibit the sale of property by corporate entities to make use of tax benefits.

Councilwoman Bichsel requested to be excused from next week's Council meeting to attend the meeting of the National Association of Washington Cities. Councilman Hyde moved to excuse Councilwoman Bichsel from the Council meeting of June 14, 1983. Seconded by Councilman Rasmussen. Voice Vote was taken and carried. The motion was declared adopted.

Councilman Hyde moved to not schedule regular City Council meetings on July 19 and August 16, 1983. Voice vote was taken and carried. The motion was declared adopted.

Councilman Hyde moved to request the Planning Commission to examine the feasibility of establishing special review districts for utilization of some of their zoning techniques to protect areas of ground water recharge from pollution. Seconded by Councilman Strege. Voice vote was taken and carried. The motion was declared adopted.

Councilman Ladenburg reported on the United Way allocation of emergency food and shelter in the City of Tacoma.

Councilman Ladenburg requested that the City Manager and the Public Utilities Department provide the Council with updated information on the memorandum dated June 3, 1983, from Kenneth Olson, Acting Water Division Superintendent. Concerns were expressed regarding the pollution of various wells and the time frames for retesting the pollution levels of the wells. City Council Minutes - Page 10 - June 7, 1983

Councilman Ladenburg requested clarification of the pollution standards and comments from the Health Department on these standards. He further requested an engineering study on the dilution of the water from the Green River Water Shed.
