COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Council Member Ladenburg requested information on the proposed changes to the Council Rules regarding rotating the presiding officer's roll call vote. He requested that the City Attorney provide back-up information regarding this proposed change from <u>Roberts Rules of Order</u>.

Council Member Kirby stated that there were still traffic problems during large events at the Tacoma Dome. He requested that the Council be briefed on the causes of the problem and possible solutions. He further requested that the Council hold a Study Session to include staff from the Traffic Engineering Division, Tacoma Dome, Police Department, and any other affected departments to discuss possible solutions to this problem.

Deputy Mayor Strege stated that at the Bacon Bowl in the Tacoma Dome an individual in a wheelchair had suggested to him that ushers be available to direct wheelchair individuals. Deputy Mayor Strege requested that staff consider posting relevant signage at dome entrys for events at the Dome.

Council Member Bichsel concurred that during large events at the Dome there were severe traffic problems that backed traffic up on I-5, and she also requested a solution.

Mayor Sutherland requested information from staff regarding any conclusions and solutions to the streetlight standard problem.
