# **REPORTS BY CITY MANAGER:**

City Manager Ray E. Corpuz, Jr. provided an update of the efforts of the Community Connection group made up of employee volunteers. He reported that they are almost completed with painting two homes for the Paint Tacoma Beautiful Project. Also, the employees' blood drive generated 36 pints of blood to increase the blood supply in the community. A second blood drive will held on August 16, 1995 from 8:00 a.m. - noon.

#### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member Miller moved to excuse the absence of Council Member Crowley from tonight's Council meeting. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Council Member De Forrest reported on a few disturbing items. One such item was the July 24, 1995 letter to the Tacoma Housing Authority Board of Commissioners from the maintenance crew at the Tacoma Housing Authority regarding alleged theft, lie detector tests, and interrogations. Council Member De Forrest asked the City Attorney if the Council had any authority over the Tacoma Housing Authority other than appointing Board members. City Attorney Robin Jenkinson replied that was correct. Council Member De Forrest asked if Board members were required to reside in the city limits of Tacoma. Council Member De Forrest also indicated that he was disturbed that the Library has hired a Bellevue law firm to find out how the Union got the "stolen"

document into the hands of Council Member Kirby. He indicated that Library employees have been going through interrogation and were told employees might be subject to lie detector tests. In addition, Council Member De Forrest reported that since January 18 - June 14, 1995, the Library Board held eight meetings of which 42.8 percent of their meeting times have been spent in open session and 57.2 percent have been held executive session. He expressed concern that some type of action should be taken. Council Member De Forrest announced that the McKinley Street Festival will be held from noon to 10:00 p.m. on Saturday, August 5, 1995.

Council Member Baarsma echoed Council Member De Forrest's concerns about the amount of time the Library Board spends in executive session. Council Member Baarsma expressed his appreciation to the Mayors and City Councils of Everett and Arlington in supporting Tacoma's position opposing the importation of spent nuclear waste from foreign countries through the Port of Tacoma. Council Member Baarsma also thanked the Association of Washington Cities for supporting Tacoma's position.

Deputy Mayor Evans also expressed his concern about the situation at the Library. He then commented on the remarkable Ethnic Fest celebration that was held last weekend. He requested to see if there was something that could be done to cause the property owners on the down hill side of Tacoma Avenue South do something about cleaning up their property.

Council Member Silas thanked the neighbors and community for participating in "National Night Out" activities.

Council Member Miller expressed concern about the deteriorating position at the Library between management and employees and the meetings themselves. He suggested that the Council take some positive steps to try to intervene and communicate the City's concerns and help develop some resolutions to the situation. Council Member Miller asked to schedule a joint meeting with the Library Board to assist with the situation. Council Member Miller indicated that in the future, he would like to recognize citizens who have brought about improvements to the city. He reported that the property owner at North 21st and Orchard took it upon themselves to do some plantings to improve that intersection. Also, a business at North 51st and Pearl Street, Jungle Fever, took a vacant lot and turned it into a thriving business and the landscaping and plantings on that site have made that area a true asset and visual improvement.

Council Member Kirby indicated that a citizen had informed him that the public elevator at the Library Board does not stop at the floor where the Library Board meetings are held. He asked the City Manager to check on the accessibility to that meeting room and if there is a code to that meeting room.

Mayor Moss announce that there are many activities planned for tonight's "National Night Out" event and encouraged everyone to participate. Mayor Moss also commented on his enjoyment at Ethnic Fest.
