Gary Sullivan, Hearings Examiner, advised that his decision was affirming the Chief of the Buildings Division's administrative determination that Peace Assembly Church is required to obtain a Special Use Permit or cease operation of their educational institution. The issue is whether a Special Use Permit should be required.

The Council members stated they had received written and/or verbal communication from several people regarding this matter.

Mayor Parker advised that each side has 10 minutes to make their statements. Since the appeal is on a decision of the City, the City Attorney's Office would represent the City's side and Peace Assembly Church would represent the other side.

Michael P. Farris, attorney for Peace Assembly Church, stated their position on this matter.

Robert Hamilton, City Attorney, stated the City's position.

After discussion by Council members, Councilman Sutherland moved to concur with the decision of the Hearings Examiner and deny the appeal. Seconded by Councilman Hyde.

Roll call vote was taken, resulting as follows:

Ayes: 8 - Bichsel, Hawkins, Hyde, Kirby, Nielsen, Rasmussen, Strege and Sutherland.

Nays: 1 - Mayor Parker.
