Dennis McLerran, Urban Planner of the City Planning Department, reviewed the proposed new districts to be added to the Land Use Management Plan. He advised that changes have been suggested on page 51 of the proposed ordinance under item number 25, Storage Warehousing. The 2.0 per 1,000 square feet should be changed to 1.5 per 1,000 square feet, the 20 plus 1.5 for additional 1,000 square feet be changed to 15 plus 1.0, and the 35 plus 1.0 for each additional 1,000 square feet be changed to 25 plus 0.5 for each additional 1,000 square feet.

Mr. Hudson moved that the amendment be made. Seconded by Mr. Schroeder. Voice vote was taken and carried. The motion carried. The change is on the proposed Ordinance No. 20795.

Mr. McLerran answered questions of Council members relating to the two new planned districts.

Owen O. Hall, Owen Hall Associates, Kirkland, real estate and land developers, spoke in favor of the new planned development districts and complimented the City of Tacoma on its Land Use Management Plan.

Mr. Hudson moved that the hearing be closed. Seconded by Mr. Sonntag. Voice vote was taken and carried.
