

MINUTES OF CITY COUNCIL BUDGET HEARING

City Council Chambers
November 23, 1982

Mayor Sutherland reconvened the hearing on the 1983 Budget at 6:06 p.m.

City Council members present were: 6 - Bichsel, Hyde, Ladenburg, Nielsen, Strege and Mayor Sutherland. Absent: 3 - Hawkins, Kirby and Rasmussen.

Copies of the 1983 Preliminary Department of Public Utilities Budget and the 1983 Department of Public Utilities Budget Summary were available in the back of the Council Chambers for the public.

Mayor Sutherland announced that the hearing on the 1983 Public Utilities Budget was scheduled for 6:00 p.m. He then called upon Paul Nolan, Director of Public Utilities.

Paul Nolan, Director of Public Utilities, presented the Public Utilities budget to the Council. Mr. Nolan then introduced Anne Walton, Budget Officer, who reviewed the budget for the Light Division.

Following the presentation the Mayor announced that public testimony would be taken after the presentation on each Division's budget. He then called upon the public for questions or comments regarding the Light Division Budget.
