## REPORTS BY CITY MANAGER:

Erling O. Mork, City Manager, stated there were two items for the Council to consider.

Robert Backstein, City Attorney, stated that he had a motion for claim settlement of Hillie Nelson Mosely for the Council to consider.

Mayor Sutherland moved to that the settlement of the claim of Hillie Nelson Mosely in the amount of \$7,200.00 be authorized in accordance with the recommendation of the City Attorney. Seconded by Deputy Mayor Rasmussen. Voice vote was taken and carried. The motion was declared adopted.

Erling O. Mork, City Manager, stated that the Personnel/Labor Relations Director had two residency waivers requests to present to the Council.

Richard Sokolowski, Personnel/Labor Relations Director, stated that he was requesting a one-year extension of the residency waivers for the unclassified appointive position of Assistant Hater Superintendent for Hr. John Kerner and a one-year extension for the position of Public Utilities Director for Mr. Ted Coates.

After discussion, Mayor Sutherland moved to grant an extension of the residency waiver for a period not to exceed six months for the two positions. Seconded by Council Member Stenger. Voice vote was taken and carried. The motion was declared adopted.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Deputy Mayor Rasmussen moved to excuse Council Member Mykland from the City Council meeting of July 14, 1987. Seconded by Mayor Sutherland. Voice vote was taken and carried. The motion was declared adopted.

Council Member Harnick stated that last week he was invited to an Upper Tacoma Renaissance Association meeting at which time the group suggested that the Council review the possibility of allowing building construction on 25-foot lots. Mr. Harnick noted that a program similar to this was successful in Portland, Oregon. Mr. Harnick requested that the planning staff look into possible City Code changes and to explore the feasibility of this being allowed in Tacoma.

Mayor Sutherland stated that the City of Seattle had experiences with the 25-foot building lots and indicated there were some problems in this area. He stated that the matter should be fully studied before any Code changes.

Mayor Sutherland stated that the City Council budget workshop would be held after the City Council meeting in the Council Conference Room.
