Mayor Vialle stated she had received an early morning phone call from Congressman Dicks stating there would be \$2,000,000 available for a walkover from Union Station and Foss Waterway.

Mayor Vialle then stated that Greg Nichols, of King County, and she had gone to Washington, D.C. to testify on rapid transit. She indicated that \$18,000,000 would be made available for rail transportation between Seattle and Tacoma.

Council Member Silas stated she was very moved by the City of Destiny Awards presented to youth. She thanked Deputy Mayor Mykland for bringing this to the City of Tacoma. She also hoped that Council would be equally moved with citizen testimony and listen during testimony.

Council Member McElliott noted that one of Council Member Moss' statements during the award ceremony indicated that nothing helps teens better than a good listener. She stated that this was very apropos.
