FIRST READING OF ORDINANCES

Ordinance No. 27279

Amending Chapter 13.06 of the Municipal Code to reclassify the property located at 5038 Tacoma Mall Boulevard, from an "R-2" One-Family Dwelling District to a "C-1" General Neighborhood Commercial District for the construction of a 9,200-square-foot two-story, office/retail building. (SKXU, L.L.C.; File No. 40000027693)

Ordinance No. 27280

Vacating a portion of Union Avenue north of the intersection of South 31st Street and Union Avenue to combine the vacated right-of-way with the abutting property for the purpose of installing a free-standing advertising sign for the abutting business in the additional landscaping area. (Tacoma Land Company; File No. 124.1222)

Ordinance No. 27281

Vacating the west 9 feet of South Pine Street between South 43rd and South 45th Streets to combine the vacated right-of-way with the abutting property to create an additional landscaping area and utility corridor for the proposed construction of several town homes on the site. Ordinance No. 27282

Vacating a 20-foot strip of North Puget Sound Avenue at 3420 North 37th Street to combine the vacated right-of-way with the abutting property for construction of a detached garage. (Tom Petramalo; File No. 124.1221)

Ordinance No. 27283

Vacating the remaining portion of Nollmeyer Lane east of Yakima Avenue completing the County-City Building Beautification Project. (Pierce County; File No. 124.1214)

COMMUNICATION

FINAL READING OF ORDINANCES

Ordinance No. 27277

Accepting \$103,123 from the United States Department of Justice, Office of National Drug Control Policy, through Pierce County, to reimburse the Police Department's Clandestine Lab Team for personnel, equipment and other expenses for activities in the Northwest High Intensity Drug Trafficking Area in Pierce County to reduce the impact of methamphetamine and heroin trafficking, and the manufacturing, use, and violent crime associated with drug trafficking.

Purchase Resolution No. 36325

Awarding contracts to:

- 1. Pacific Coast Truck Center, in the amount of \$167,354.23, plus sales tax, for two 2005 International cab and chassis Washington State Contract No. 07503;
- Petrocard Systems, Inc., in the amount of \$2,220,000.00, plus sales tax, to increase its contract to a cumulative total of \$7,477,210.50, for cardlock and mobile fueling services – Specification No. FLT-001-01;
- Raymond Handling Concepts Corporation, in the amount of \$34,836.00, plus sales tax, to increase its contract to a cumulative total of \$105,858.00, for four Taylor Dunn stake-bed burden carriers for the Central Wastewater Treatment Plant – Informal Bid No. 20281;

Resolution No. 36326

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with Home Options, Inc., to construct eight market-rate rental condominium units located at 3119 South 45th Street in the Tacoma Mall Mixed Use District.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Authorizing the execution of a Collective Bargaining Agreement negotiated with District Lodge 160, on behalf of Local Lodge 297 of the International Association of Machinists and Aerospace Workers, Tacoma Rail Mechanics Unit, which covers approximately five employees, effective January 1, 2002, through December 31, 2008.

Resolution No. 36328

Designating the Idius M. Larsen Home located at 3102 North 30th Street as a historic landmark and placing said building on the Tacoma Register of Historic Places.

Deputy Mayor Evans moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36329

Authorizing the execution of a Historic Preservation Special Valuation Tax Covenant for rehabilitation of the properties at the following locations: 3102 North 30th and 616 North M Streets.

Council Member Phelps moved that the Resolution be adopted. Seconded by Council Member Talbert. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36330

Authorizing the execution of agreements between the Board of Administration of the Tacoma Employes' Retirement System and the Northern Trust Company, in an estimated amount of \$245,000, for custodial and passive equity management services for the period of January 1, 2005, through December 31, 2005; and Russell Mellon Analytical Services, in the amount of \$22,500 per year, for portfolio verification services for the period of January 1, 2005, through December 31, 2006.

City Manager James Walton shared information about the Budget workshop documents being available online. He also called on Mr. Bill Pugh, Public Works Director, for an explanation about the cleanup effort regarding the contamination in the Foss Waterway. He also requested an Executive Session not to exceed 60 minutes for Labor and Real Estate negotiations.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Lonergan mentioned the Crime Statistics report provided by Police Chief Ramsdell indicating crime in Tacoma has decreased.

Council Member Anderson mentioned a recent article in the *The News Tribune* regarding the food and clothing distribution activities near the 25th and A streets parking lot. She stated the City would relax the "no trespassing" enforcement for two weeks ending November 6th to give the ministry some time to find an alternate solution. She also stated a Resolution to address the performance audit for the SAP system will be on an upcoming City Council agenda.

Mayor Baarsma reported an Appointments Committee recommendation to examine the production costs for the City of Destiny awards ceremony.

Mayor Baarsma moved to convene to Executive Session to discuss Labor and Real Estate negotiations, the session not to exceed 60 minutes. Seconded by Council Member Phelps. Voice vote was taken and carried. The motion was declared adopted.

Council convened to Executive Session at 7:47 p.m. Mayor Baarsma returned at 8:45 p.m. and extended the Session another 30 minutes. Mayor Baarsma returned at 9:15 p.m. and extended the Session an additional 30 minutes. Council reconvened at 9:32 p.m.
