He stated he had toured the new \$40 million Marshall Avenue Auto Facility in the Port District and congratulated the Port for receiving the one millionth Mazda vehicle to be imported to the United States through the Port. He also congratulated the Auto Warehousing Company for the 2004 RX-8, which is one of the 3.2 million vehicles imported.

Deputy Mayor Evans stated next Monday is the Martin Luther King, Jr. Day celebration at the Tacoma Dome, from 11 a.m. to 1 p.m. He invited everyone to attend.

Council Member Phelps announced that Pat Flynn, Community Relations, retired last December and thanked her for her many contributions.

Mayor Baarsma mentioned the City Council's Workshop held last weekend. He stated five standing committees were created: Economic Development Committee, Committee on Neighborhoods and Housing, Committee on Government Performance and Finance, Public Safety Committee, Committee on the Environment and Public Works. He stated each committee is eager for citizen advice and involvement.

Mayor Baarsma stated he and Council Member Lonergan attended the ribbon-cutting for three new buildings at the University of Washington Tacoma Campus.
