CITY COUNCIL MINUTES

City Council Chambers June 1, 1993

The meeting was called to order at 5:10 p.m.

Present on roll call: 8 - Baarsma, Evans, McElliott, Miller, Moss, Mykland, Nielsen, and Mayor Vialle. Absent: 1 - Silas.

The Flag Salute was led by Council Member Miller.

Approval of the minutes of the Tacoma City Council meeting of May 25, 1993 and study sessions of April 27 and May 4 and 18, 1993.

RESOLUTIONS:

Resolution No. 32209

Setting Tuesday, June 8, 1993, at approximately 6:00 p.m. as the date for a public hearing by the City Council to consider the proposed annexation of properties located between the City of Tacoma and the City of Fife, generally south of East-West Road.

APPEALS:

Adopting "Tacoma Tomorrow: The Strategic Plan for Tacoma City Government" and directing the City Manager to initiate a formal process to establish, maintain and review comprehensive plans setting forth goals and policies for the City.

Council Member Evans moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 32216

Authorizing the execution of an agreement with the National Development Council to assist with economic development projects from July 1, 1993 to December 31, 1994.

Council Member Nielsen moved that the Resolution be adopted. Seconded by Council Member Baarsma. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 32217

Authorizing the execution of an agreement with the Tacoma Housing Authority in the amount of \$120,000 for utilization of the 1992 HOME funds for implementation of the Tenant-Based Rental Assistance Program.

Mayor Vialle moved to continue Resolution No. 32117 to the meeting of June 8, 1993. Seconded Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

UNFINISHED BUSINESS:

REPORTS BY CITY MANAGER:

Mr. Ray E. Corpuz, Jr., City Manager, indicated that a notice was distributed to Council inviting the Council to a kickoff press conference to help the buy-back program on the confiscation of fire arms. Mayor Vialle also thanked Seattle Council Member, Margaret Pager for her efforts in this program. Mr. Corpuz requested an executive session to discuss pending and potential litigation.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Vialle announced that Governor Lowery signed into bill the second year of criminal justice funding.

Council Member Miller complimented the Council for its decision not to rely on non-existent criminal justice monies during the budget process. He also thanked the efforts of the Tacoma and Seattle Councils for obtaining criminal justice funding.

Council Member Baarsma indicated he was pleased to read in this morning's newspaper, that the action the Council took in concert with the County Council in support of the Tacoma-Pierce County Humane Society seems to be paying off. He indicated this has been the first time in the history of the Tacoma-Pierce County Humane Society that there was an actual day in which Humane Society employees were not required to kill animals. There was a 29 percent decline in the current rate which meant Humane Society employees can devote more time to education and enforcement rather than the killing of animals.

Mayor Vialle moved to recess to Executive Session to discuss potential and pending litigation, the session not to exceed 15 minutes. Seconded by

Council Member Miller. Voice vote was taken and carried. The motion was declared adopted.

Council recessed to Executive Session at 6:55 p.m. and reconvened at 7:10 p.m.

Mayor Vialle moved that the lawsuit of <u>Louis Zubaly v. Tacoma Public Hearing Board, et al.</u>, Pierce County Superior Court Cause No. 93-2-02643-4 be settled in the sum of \$60,000 in accordance with the terms contained in the settlement agreement on file with the City Clerk. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

On proper motion, the meeting was adjourned at 7:10 p.m.
