### REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. stated that he has provided information to the City Council regarding the request from the Boys and Girls Clubs to keep open four of their facilities during the summer months. He then stated that a resolution would be forthcoming for the City Council's consideration. Mr. Corpuz stated that the City's contribution would be \$10,000 of a \$40,000 budget.

### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Evans stated that the Boys and Girls Clubs are beginning a new program which will open their buildings to the general population, including adults. He stated that this is a pilot program and worthy of support.

Council Member Miller stated that he had received information on housing in the Tacoma area listing the median price of a 4-bedroom home at \$192,000. He stated that he thought the price was on the high side and requested follow-up information as to how this price was determined.

Council Member Miller requested a study session to discuss the recommendations of the Planning Commission regarding billboards.

Council Member Miller suggested looking at the way Seattle is developing a match fund similar to the one the City of Tacoma is using with the Neighborhood Councils, to annually appropriate amounts which the neighborhood's match by including volunteer labor.

Council Member Miller announced that the City of Tacoma's sidewalks are in outstanding condition compared to the sidewalks in Washington, D.C.

Council Member Crowley congratulated the News Tribune on the great coverage of the Sound to Narrows race in Sunday's newspaper. He stated that over 12,000 people participated in the race.

Council Member Silas stated she and Mayor Ebersole had attended the 71st Convention at the New Jerusalem Church. She stated that they both had a wonderful time and commended the participants.

Council Member Silas requested that the City Manager work with Catholic Community Services to see if the City of Tacoma can help them find another facility. She stated that the project was a very worthy one.

Mayor Ebersole announced that the City of Destiny Awards Ceremony will begin at 7:00 p.m. at the Rialto Theater. He stated that the ceremony is the City of Tacoma's chance to recognize the volunteers who are making our City a better place in which to work and live.

Council Member Miller reminded everyone to vote by mailing in their ballots regarding the Stadium issue by midnight tonight.

On proper motion, the meeting was adjourned at 6:43 p.m.
