## FIRST READING OF ORDINANCES

#### Ordinance No. 25937

Amending Chapter 13.06 of the Municipal Code to reclassify the property located at 2701 South Orchard Street from a "R-2" One-Family Dwelling District to a "C-2" Commercial District to allow a 154,717-square-foot hardware and garden supply store on a 16.1-acre site east of Orchard Street and north of Center Street. (Eagle Hardware & Garden, Inc.; File No. REZ96-00007)

Council Member De Forrest moved to continue Ordinance No. 25937 to August 13, 1996. Seconded by Mayor Ebersole. Voice vote was taken and failed with Council Members De Forrest and Kirby voting "Aye." The motion was declared failed.

Council Member Baarsma moved to concur in the Findings, Conclusions and Recommendations of the Hearing Examiner. Seconded by Council Member McGavick. Voice vote was taken and carried with Council Members Kirby and De Forrest voting in opposition. The motion was declared adopted.

#### Resolution No. 33476

Authorizing the execution of Amendment No. 133 to the Neighborhood Preservation Program Agreement with the Tacoma Community Redevelopment Authority to allocate \$48,000 in 1996 HOME Investment Partnership funds and \$12,050 in 1996 Emergency Shelter Grant funds for a "write-down" loan to Faith Homes for renovating the facility at 1920 North Union.

Council Member Evans moved that the Resolution be adopted. Seconded by Council Member Miller. Voice vote was taken and carried. The Resolution was declared adopted.

#### Resolution No. 33477

Authorizing the execution of agreements with Piper Jaffray and Preston Gates & Ellis to analyze existing debt obligations and assist the City in the preparation of debt restructure to provide capital for construction of various infrastructure upgrades and

capital improvement projects to address neighborhood needs, public safety facilities, and economic development of the Foss Waterway.

Council Member Miller moved to continue Resolution No. 33477 to the meeting of August 13, 1996. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Council Member Evans requested a progress report regarding the enforcement of the sidewalk ordinances. He then asked if there are any plans in process to improve the open space property south of Harbor Lights on Ruston Way which is currently being used as a parking lot. Council Member Evans stated that, on behalf of Mayor Ebersole, he attended the dedication of a mural at 12th Street and Pacific Avenue and encouraged everyone to see it. He then stated that it was created by homeless children at Tone School with the cooperation of Stadium High School's ceramics class.

Deputy Mayor Silas announced that tonight is National Night Out and thanked all the citizens that participated and invited her to their potluck.

Mayor Ebersole announced that the Washington State History Museum will have their grand opening on Saturday, August 10, and Sunday, August 11, 1996, and encouraged everyone to attend. He also thanked the citizens for participating in National Night Out.
