City Manager Ray E. Corpuz Jr. requested an six-month additional residency waiver for Ms. Trinh Tran to continue to fill the position of Legal Intern in the Criminal Justice Division.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Crowley moved to authorize the City Manager to grant an additional six-month residency waiver for Ms. Trinh Tran to continue to fill the position of Legal Intern in the Criminal Justice Division. Seconded by Council Member Baarsma. Voice vote was taken and carried. The motion was declared adopted.

Deputy Mayor Kirby stated that information he has read in the Editorial Section of *The News Tribune* regarding the Emergency Medical Services Levy was inconsistent with other information he has received and asked for clarification.

Mr. Pat McElligott, Tacoma Firefighter, gave a brief clarification of the ballot issue.

Council Member De Forrest stated that Deputy Mayor Kirby's questioning of the Emergency Medical Service ballot issue was very close to violating state law. He asked for clarification so that, in the future, City Council Members are careful about discussing ballot issues.

Council Member Baarsma thanked Robin Jenkinson, City Attorney, for responding to his inquiries regarding Ordinance No. 25789 with involves limited tax exemptions for multi-family residential housing. Council Member Baarsma asked whether or not it would be possible to amend the ordinance to include a sunset provision so that in the future the City Council could reconsider the ordinance in the event the housing market changes and there is no need to provide this incentive.

Council Member McGavick noted that Congressman Norm Dicks was in town last week for his Annual Advisory Committee Meeting for women professionals and business leaders in Tacoma. She stated that Congressman Dicks announced that the Hilltop Artist-in-Residence Program won the 1999 Coming Up Taller Award as well as \$10,000 given by the National Endowment for the Arts. She stated that Ms. Kathy Kaperick, former Director of the Hilltop Artist-in-Residence Program, is in Taos, New Mexico and has formed a joint partnership between Taos and Tacoma. She stated that the program in Tacoma has been relocated to Wilson High School while Jason Lee Middle School is being remodeled.

Mayor Ebersole reminded everyone that the City Council meeting and Study Session for Tuesday, September 7, 1999, have been canceled. He stated that the next regularly scheduled City Council meeting will be held on Tuesday, September 14, 1999, at 5:00 p.m. in the Council Chambers; and the Study Session will be held at 12:00 noon in Room 16 of the Tacoma Municipal Building North.

Mayor Ebersole stated that he was pleased to have represented the City of Tacoma at the groundbreaking of the Columbia Bank tower on A Street today. He said that Mr. Ervain Haub, the developer from Germany, was present and expressed interest in not only completing this office tower but possibly developing the other piece of property he owns in downtown Tacoma.

On proper motion, the meeting was adjourned at 8:23 p.m.
