The meeting was called to order at 5:04 p.m.

Councilman Rasmussen made the following comments:

"As I recall the discussion last night at the workshop centered around, in terms of the half cent sales tax increase, centered around the fact that that is not part of the draft budget to date. And I would suggest that we look at it in just that way. Discussion also centered around many other methods of distributing that money back to citizens of Tacoma. One of the things that was brought up was, and I'd like that to be in the record, in the minutes, was the fact that we could draw down on either the excess levy on the Dome or the inside levy on the Dome, thus giving us the ability for capital programs in the future and that being just one of the alternatives. I would like to make sure that we, as a Council, at least leave the avenues open to how we can distribute those funds back. I don't think it's the intent, at least I didn't hear that last night, it was the intent of the Council to include that half cent sales tax in the budget." COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Rasmussen requested the City Attorney to prepare a draft ordinance of an Ethics Code for the Council, taking into consideration the employee rules of the City of Tacoma, Charter of the City of Tacoma, current State law dealing with disclosure of elected officials and Substitute No. 3, Ordinance No. 22774.

Councilman Hawkins asked the City Attorney to provide the Council with the original draft of the Ethics Code that was proposed in March 1981. He also asked that the City Attorney prepare a charter amendment that provides for a popular initiative and referendum.

Mayor Sutherland moved to excuse Councilwoman Bichsel and Mayor Sutherland from next week's meeting. Seconded by Councilman Hyde. Voice vote was taken and carried.

Councilman Ladenburg requested that the City Attorney review a number of points in the memo prepared by the City Attorney's office regarding the Ethics Code.

Mayor Sutherland announced that on October 23, 1982, at approximately 12:00 noon, the U.S.S. Copeland will arrive in the City of Tacoma. The Mayor has appointed an ad hoc committee to coordinate the welcoming activities for this event. The coordinator of the committee will be Ken Russell. Other members of the committee include Robert Copeland, Jr., Bruce McKenzie, Mark Anderson, Captain Paul Smith, Ed Hudson, Joe Fortier, and Ellida Kirk-Lathrop. The Mayor introduced Mr. Russell, who spoke to the Council regarding the welcoming ceremonies and invited the citizens of Tacoma to participate.

Councilman Hawkins moved to recess into Executive Session for purposes of discussing personnel. Seconded by Deputy Mayor Nielsen. Voice vote was taken and carried. Council recessed at 6:45 p.m. and reconvened at 7:53 p.m.
