### COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Council Member De Forrest expressed concern regarding enforcement of an Ordinance passed last year commonly known as "Three Strikes and You're In". He stated that enforcement of the Ordinance may have prevented the recent deaths, apparently due to domestic violence, of East Tacoma residents. Council Member De Forrest requested information regarding why the Ordinance was not enforced and what could have been done to prevent these deaths.

Council Member Kirby requested information regarding staffing levels in the City Prosecutor's office.

Council Member Baarsma extended his condolences to Council Member Miller and his family in the passing away of Council Member Miller's mother. Council Member Baarsma commented on the public safety issue regarding the City and County of Spokane by reading a section of an article in the <u>Seattle Post Intelligencer</u> regarding comments, made by the County Sheriff and the Commissioners, that some Spokane County services, including deputies, may have to be eliminated due to budget shortfall.

He noted that areas other than Tacoma and Pierce County were experiencing serious crime problems.

Deputy Mayor Evans stated that he and Randy Lewis, Government Relations Officer, attended a meeting along with representatives of the Puyallup Tribe regarding problems experienced by residents who live near a particular smoke shop in Northeast Tacoma. Deputy Mayor Evans reported that he will be meeting again with Puyallup Tribe representatives, including an individual recently hired to review the Puyallup Nation's land plan. Deputy Mayor Evans also reported that he attended a meeting with representatives from Randy Tate's office regarding a proposed FAA study of flight plan revisions.

Council Member Silas expressed her sympathy to Council Member Miller and his family in the loss of Council Member Miller's mother.

Mayor Moss also extended his condolences to Council Member Miller.

Mayor Moss moved to excuse Council Member Miller and Council Member McGavick. Seconded by Deputy Mayor Evans. Voice vote was taken and carried. The motion was declared adopted.

Mayor Moss moved to cancel the City Council meetings of December 19 and 26, 1995, and January 2, 1996. Seconded by Council Member Silas. Voice vote was taken and carried. The motion was declared adopted.

Mayor Moss moved to recess to Executive Session to discuss pending litigation, not to exceed 15 minutes. Seconded by Deputy Mayor Evans. Voice vote was taken and carried. The motion was declared adopted.
