FINAL READING OF ORDINANCES

Substitute Ordinance No. 27014

Amending Chapter 13.06 of the Municipal Code relating to zoning; adopting amendments to the comprehensive plan consisting of a new Introduction Chapter; the Capital Facilities Program 2003-2008; the Transportation Program; and the Generalized Land Use Plan; adding a new section to be known and designated as Section 13.06.110(44) reclassifying the property located in the vicinity of South 69th and Tyler Streets from an "R-3" Two-Family Dwelling District to an "R-2" One-Family Dwelling District.

Deputy Mayor McGavick moved to continue Substitute Ordinance No. 27014 to the meeting of December 10, 2002. Seconded by Council Member Phelps. Voice vote was taken and carried. The motion was declared adopted.

Amending Chapters 13.04, 13.05, 13.06 and 13.16 of the Municipal Code relating to the Land Use Regulatory Code; transferring certain responsibilities from the Building and Land Use Services Division Manager to the Land Use Administrator; enhancing the administration and implementation of the newly adopted zoning regulations; clarifying reporting responsibilities within the Building and Land Use Services Division; and improving customer service.

Council Member Phelps moved to amend Ordinance No. 27017 by adding the following language: Additionally, the Public Works Director to report back to the City Council 12 months hence after reviewing the effectiveness of the Ordinance.
