REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr., reported on the new partnership with the Federal Bureau of Investigation (FBI). He stated that the FBI has agreed to a partnership involving the City of Tacoma and Pierce County which will direct federal and local resources in the area of dealing with the most serious outstanding warrants. He stated that this program is scheduled to begin this summer.

Mr. Corpuz then commented on residency waivers for individuals being considered for employment at Tacoma City Light and indicated that Mr. Jan Gilbertson was in the audience to speak on this issue.

Mayor Ebersole called on Mr. Jan Gilbertson, who spoke regarding residency waivers for two Special Projects Engineers for the Tacoma Public Utilities Light Division.

Deputy Mayor Baarsma moved to waive the residency requirement for the candidate for the Special Projects Engineer position who currently resides within the Tacoma Public Utilities Light Division's service area. Seconded by Council Member Evans.

Roll call vote was taken, resulting as follows:

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Mayor Ebersole stated that there had been some unusual and tragic circumstances over the past few weeks, which culminated Friday with the funeral for Corey Pittman. Mayor Ebersole thanked Chief Arreola and other members of the community who had come to the funeral to pay their respects to the family, which he felt did help the healing process. He then complimented Chief Arreola, Detective Karen Kelly, and the other members of the Police Department who worked very hard and long hours to solve these homicides. Mayor Ebersole stated that the phenomena of young men and women shooting each other and killing each other in our community and throughout America is incredibly tragic and frustrating. He stated that we all need to recommit ourselves to doing what we can in our neighborhoods in working with the police, churches, and organizations to reach out to these youth and teach them a different way and let them teach each other that solving disputes with guns is not acceptable.

Deputy Mayor Baarsma thanked the Mayor for the terrific job in representing the Council at Corey Pittman's funeral. He stated that Mr. Pittman had symbolized so many hopes and expectations on the part of all of us. He also thanked Chief Arreola and the Police Department for their good work in solving this case and the other many tragedies in our community. Deputy Mayor Baarsma stated that for the first time in history, the Tacoma City Council and the Pierce County Council meetings were being simulcast on Channels 12 and 28. He stated that starting at 3:00 p.m. on Tuesdays the County Council's meeting would be broadcast live and then the City Council's meeting would be broadcast live. He stated that with the Regional Media Center, which will be located at the Clover Park Technical College in July, there would be other future possibilities.

Council Member De Forrest thanked the Mayor for his comments and stated he agreed with them. He stated that there are some homicides which are still unsolved and requested a list of unsolved homicides in our community. Council Member De Forrest stated that he had noticed that Tacoma's crime rate had gone down again, as it had throughout the nation, and hoped we would continue in that direction. He reported that of the twelve killings this year in the City of Tacoma, 50 percent of them were in East Tacoma and 33 percent on McKinley Avenue. He stated he felt the Chief was doing a good job in emphasizing prevention and patrolling the area. Council Member De Forrest requested information regarding the flooding last Friday between 19th and 23rd Streets on Pacific Avenue.

Council Member Silas also expressed her appreciation to the Chief and people of the Police Department in their speedy apprehension of the fugitives who took a life without a second thought. She hoped that preventive programs and putting people to work would be looked into. She stated that she believed people who were not idle, but who are employable, and can be trained for jobs, will take another path. Council Member Silas stated that she was saddened when she heard that the police are not responding to noise disturbances and asked the City Manager to take a look at the Noise Ordinance that we have and see what we can do about the noise disturbances.

Council Member Evans reported that the Tacoma-Pierce County Health Department meets in its regular session and would be addressing the issues of crime, death and murder. He stated that the Health Department is going to present a Resolution and a letter to the City Council asking for the restoration of funding to the Health Department that was removed last year. Council Member Evans stated that these funds will primarily go to prevention programs and urged the Council to remember what was said tonight about prevention programs and act accordingly when the funding is requested for those programs.

Council Member Crowley reminded everyone that the American Heart Association breakfast is tomorrow morning at 7:30 a.m. with Jim Zorn, former quarterback for the Seattle Seahawks, as a guest speaker.

Council Member McGavick stated that yesterday she had started her new life as president-elect of Clover Park Technical College. She stated she had received a letter from the City of Lakewood welcoming her as a partner in economic development efforts and requesting to meet with her to discuss mutual benefits to the City of Lakewood. Council Member McGavick reminded City Manager Corpuz and Mayor Ebersole that Clover Park Technical College is a regional college and that she would be happy to sit down with the leaders of Tacoma to look at efforts in terms of mutual benefit for economic development and projects.

Mayor Ebersole wished Council Member Kirby well. He stated that Council Member Kirby had undergone some rather painful health problems this past week that were quite serious.

Council Member Miller moved to cancel the City Council meeting of August 5, 1997. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

On proper motion, the meeting was adjourned at 7:45 p.m.
