Authorizing the execution of Amendment No. 234 to the Tacoma Community Redevelopment Authority (TCRA) Agreement, allocating \$470,391 of 2004-2005 HOME funds for the City of Lakewood's housing programs; and \$50,870 in American Dream Downpayment Initiative funds for the City of Lakewood's first time homebuyers.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36497

Authorizing the execution of Amendment No. 235 to the Tacoma Community Redevelopment Authority (TCRA) Agreement allocating to the TCRA \$1,041,545 of 30th Year Community Development Block Grant funds, and \$1,595,755 of 2004-2005 HOME funds, including \$82,195 for the Community Housing Development Organizations and \$178,268 for the American Dream Downpayment Initiative.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Evans. Voice vote was taken and carried. The Resolution was declared adopted.

Deputy Mayor Ladenburg moved to excuse Council Member Phelps from the meeting. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.



Deputy Mayor Ladenburg moved to excuse Council Member Talbert from the meeting. Seconded by Council Member Evans. Voice vote was taken and carried. The motion was declared adopted.

Mayor Baarsma read a press release "Blight Put to Flight." He called on Mr. Doug Delin, Eastside resident, for a brief overview on the new "T.E.A.M. Up On Trash" event who presented the Most Valuable Player award to Mr. Bill Collins, Public Works Building and Land Use Services Division. He also thanked other City staff for their efforts.

Deputy Mayor Ladenburg mentioned "Teacher Appreciation Week."

Council Member Anderson mentioned her recent participation in the "Rebuilding Together" project. She stated there were 19 projects in one weekend involving home repairs for people who were disabled, elderly, or for some reason unable to take of their homes or continue to live in their homes without help. She stated there were 450 volunteers, \$300,000 in cash donations, and untold amounts of "in kind" donations. She reported she attended the Habitat for Humanity "Women Build" event for female workers.

Council Member Evans announced that there will soon be a third farmers market operating located at the Freight House Square Light Rail stop on Tuesdays.

Council Member Lonergan welcomed the City Manager candidates to the City. He acknowledged Ms. Gwen Kopetzky, Assistant to the City Manager, Ms. Cindy Leingang, Administrative Secretary, and Ms. Cheryl Jensen, Administrative Assistant, for helping with the process. He mentioned that the City of Tacoma has had a great City Manager for the last two years and congratulated City Manager James Walton for a job well done. He also saluted two employees with 30 years of service to the City: Mr. Richard Hoover, Public Works Department; and Mr. Wayne McCrory, Public Works Department.

Council Member Manthou also thanked Ms. Gwen Kopetzky and other staff for their behind-the-scene efforts in preparation for the City Manager selection process.

Mayor Baarsma thanked Ms. Cindy Leingang for her many hours over the weekend preparing for the arrival of the City Manager candidates. He also mentioned that on May 1st he issued three proclamations: "Loyalty Day", "Vietnam Veterans Memorial Week," and "Labor Day."
