Bob Hamilton, City Attorney, stated that a suit has been filed in this particular instance by one of the business property owners.

James Mason, Attorney, representing Mr. & Mrs. Milton Thompson of 625 South Winnifred as well as other neighbors in the area south of Sixth Avenue and in the vicinity of Winnifred or living along Winnifred;

Moe Birnbaul, Attorney, representing Pos-A-Traction Tires and North Coast Electronics, the two businesses that have filed the law suit: Charles Jenkins, 616 South Winnifred; and Anita Thompson, 625 South Winnifred.

Ordinance No. 22857

Amending Chapter 9.08 of the Official Code relating to public ways and street occupancies.

Councilman Hyde moved that this ordinance be held over for first reading in two weeks so that the Planning Department can review it. Seconded by Councilman Rasmussen. Voice vote was taken and carried.

First reading of the Ordinance was set over to January 11, 1983.

Ordinance No. 22858

Authorizing the establishment of the Project Need Program Fund and appropriating \$50,000.00 or so much thereof as may be necessary from said fund for carrying out the Project Need Program.

Speaking on the Ordinance was Warren Johnson of the Metropolitan Development Council.

The Ordinance was set over for final reading next week.

Voice vote was taken on the Resolution, as amended, and carried. The Resolution, as amended, was declared adopted.

Resolution No. 27694

Authorizing the execution of revisions to Exhibits C and D of the General Transfer Agreement with the Bonneville Power Administration.

Councilman Rasmussen moved that the Resolution be adopted. Seconded by Councilwoman Bichsel. Voice vote was taken and carried. The Resolution was declared adopted.

COMMENTS AND COMMITTEE REPORTS BY MEMBERS OF THE CITY COUNCIL:

Councilman Hawkins gave a report on the Executive Board Meeting of the Council of Governments that was held last Thursday.

Councilman Strege said that he had read articles in both the Tacoma and Seattle papers wherein it was stated that Tacoma and Pierce County had been listed as "a non-attainment area" under the Federal-Clean Air Act. He went on to state that the Environmental Protection Agency had sent Tacoma documents indicating how we could comply with the Clean Air Act. He asked to receive a copy of the documents that were sent to us and if this couldn't be a topic for discussion at a Study Session some time in the future.

Mayor Sutherland gave a recount of the City's achievements for the past year and talked about the goals for the coming year.
