Authorizing the submittal of the 2002 Annual Action Plan of the Consolidated Plan to the United States Department of Housing and Urban Development.

Council Member Phelps moved to amend the 2002 Annual Action Plan of the Consolidated Plan on page 15, by reducing the amount of Community Development Block Grant (CDBG) funding allocated to the Martin Luther King Housing Development Association (MLKHDA)/King Center – Men's and Women's Overnight Emergency Shelters from \$30,528 to \$29,089; thereby reducing funding by \$1,439 and reducing the subtotal of Public Services funding from \$466,650 to \$465,211; and on page 47, reduce the amount of CDBG funds allocated to MLKHDA/King Center – Men's and Women's Overnight Emergency Shelters from \$30,528 to \$29,089, and reduce the Total funding reflected on that page from \$50,528 to \$49,089; and on page 64, increase the amount of CDBG Public Services Contingency funds from \$30,000, to \$31,439. Seconded by Deputy Mayor McGavick.

Council Member Lonergan recused himself from the discussion and left the Chambers.

City Manager Ray E. Corpuz, Jr. stated the Tacoma Link Construction update is on the City's web page at Cityoftacoma.org, under current news, where there is a new link entitle "Road Construction Updates." He stated other transportation projects can also be found on the web page.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor McGavick stated she represented the Mayor last week at the Slavic Christian Center, and that Senator Paull Shin, 21st District, also attended. She stated

the event was a good example of how ethnic groups meld together in our society. She stated she also attended a prayer breakfast, which had a wonderful speaker and good music.

Council Member Phelps encouraged citizens to make an extra effort to support the merchants and businesses in the construction area on Pacific Avenue. He stated the University of Washington has opened up additional parking in the area, at least two lanes will be open to traffic at all times, and the shuttle is operating from early in the morning until early evening.

Council Member Talbert stated there is an opening on the Urban Policy Committee and encouraged people, especially those in the East or South End of Tacoma to apply. He believed the deadline to be May 13 and that applications could be obtained from Mary Hodgman in the Council office at 591-5100.

Council Member Miller stated Mother's Day would be a good day to support the businesses in the lower Pacific Avenue area. He also stated he would like to see the Arts Commission establish a program enabling local artists to showcase their art in the Council Chambers.

Council Member Moss recognized students in the audience who attended the Council meeting.

Council Member Lonergan discussed the Meth Summit held May 6, 2002, and credited Lisa O'Hanlon, Safe Streets, for successful coordination of the event. He stated he is a member of the Safe Streets Board and that they are working hard to decrease the number of Meth manufacturing centers. He stated he attended a kickoff event for Potter's House, founded by Ruth and Kristi Anderson, to help runaway youth in the community. Council Member Lonergan noted the passing of Janabea Wilson, the mother of former Council Member Dolores Silas. He stated the funeral would be Friday, 2:30 p.m., at Mt. View.

Mayor Baarsma attended the roll out advertising campaign to encourage businesses in northern Washington to consider moving to Tacoma. He thanked Juli Wilkerson, director of Tacoma Economic Development, and Dan Voelpel, communications supervisor of General Services, along with their staff, for the terrific job. He stated the advertising was being seen, heard, and read on many television stations, radios, and newspapers.

Mayor Baarsma extended his appreciation to the 75 people he joined with on the Hilltop for Operation Clean Sweep and was glad to report that there was much less litter this year.

Council Member Ladenburg stated she attended the Law Enforcement Memorial Service honoring officers, since the inception of our State, who have died in the line of duty.
