Mr. Sonntag said he is assigned to attend Regional meetings of the Puget Sound Council of Governments and advised he would be unable to attend tomorrow night's meeting. He asked that another member of the Council attend in his place. Mayor Johnston advised he would attend.

Mr. Warnick commented on last years' study session's for review of the budget and felt the method should be continued this year.

Mr. Hudson said that due to business commitments he was unable to attend last night's meeting with the Park Board, however, he had a series of questions for the Park Board and asked that staff circulate his questions through the Council members and come to an agreement on a group of questions to ask the Park Board.

Mayor Johnston reminded Council of the dedication ceremonies tomorrow of the new bus station on Commerce Street and urged that they attend.

Mayor Johnston advised that at the noon Study Session this date it had been decided to expand the Revenue Sharing Citizens' Advisory Committee. Mayor Johnston made a motion then to add to the Committee the names of Lawanna Lee, 4810 K Street East and Eugene Matsusaka, 3336 North Baltimore. Seconded by Mr. Sonntag. Voice vote was taken and carried.

Mayor Johnston reported that Mr. Hudson has asked to be relieved of his assignment on the Civic Arts Commission because of his increasing involvement in the Puget Council of Governments. Mayor Johnston said he would accept Mr. Hudson's resignation with regrets and he appointed Deputy Mayor Jack Warnick as the Council's member to the Civic Arts Commission.
