The meeting was called to order at 5:09 p.m.

Amending Chapter 11.05 of the Municipal Code reducing the speed limits from 35 mph to 30 mph on the following streets:

- North 26th Street from Pearl Street to Narrows Drive;
- South 74th Street from I-5 to South Tacoma Way; and
- Narrows Drive from Jackson Avenue to North 37th Street; and from 30 mph to 25 mph on:

Amending Chapter 13.06 of the Municipal Code to implement the Industrial Zoning Code Update; to combine numerous industrial uses into two broad categories to clarify sign, landscaping and other development requirements in industrial districts; to restrict certain non-industrial uses in the industrial districts; to re-designate "M-3" Heavy Industrial District to "PMI" Port Maritime & Industrial District, to maintain consistency within the Zoning Code; and to complete a rezoning from "R-2-T" Residential Commercial Transitional District to "T" Transitional District.
