REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. acknowledged Tacomaspace.com for their nomination for a regional economic's award, the Vision 2020 Award. Council Member Evans then stated that a special exhibit called "The Man Behind the Myth" opened at the Washington State History Museum. He stated that the exhibit is the story of George Washington. He stated that priceless artifacts from the University of Virginia and the home of George Washington, Mt. Vernon, are on display. Council Member Evans encouraged everyone to take advantage of this educational opportunity. He then congratulated and thanked David Nicandri, Director of the Washington State History Museum, for bringing the exhibit here.
