FIRST READING OF ORDINANCES

Ordinance No. 27347

Amending Chapter 9.30 of the Municipal Code, relating to the Fourth of July celebration, to clarify the City Council's discretion to continue to contract with the Tacoma Events Commission, a non-profit organization, to present the event for as long as the City Council is satisfied with its performance.

The Ordinance was considered and removed from the agenda earlier in the meeting.

Ordinance No. 27348

Amending the 2005-2006 Biennial Budget to appropriate funds for 2003-2004 contract obligations, transfers, and other budget adjustments; accepting, depositing in and appropriating miscellaneous donations, contributions, and/or fees; creating the General Services Special Revenue Fund; and declaring an emergency, making necessary the passage of this ordinance and its taking effect immediately upon publication.

The Ordinance was set over for final reading next week.

Ordinance No. 27349

Amending Chapter 1.12 of the Municipal Code, relating to the Compensation Plan, to delete language regarding vacation and personal time off during the implementation of the Business Systems Improvement Project; creating new classified classifications; changing and/or deleting obsolete titles for various classified and appointive classifications; and implementing provisions of a Letter of Understanding negotiated with International Brotherhood of Electrical Workers, Local 483, regarding work flexibility at the Wynoochee River Project.

The Ordinance was set over for final reading next week.

Awarding contracts to:

Deputy Mayor Ladenburg moved that the Purchase Resolution, including waiving formal bidding procedures on Item No. 4, be adopted. Seconded by Council Member Phelps.

Council Member Phelps moved to waive further reading of the Purchase Resolution based on information provided. Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

Council Member Lonergan reviewed all seven items for the record.

Voice vote was taken and carried on the Purchase Resolution. The Purchase Resolution, including waiving formal bidding procedures on Item No. 4, was declared adopted.

Resolution No. 36478

Authorizing the submittal of a grant application to the United States Department of Justice, Office of Justice Programs, in the amount of \$539,716, for the Edward Byrne Justice Assistance Grant, which will be equally distributed between the City and Pierce County.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36479

Authorizing the execution of a Multi-Family Housing Limited Property Tax Exemption Agreement with Wet Fly Investments, LLC, for the construction of 12 market-rate apartments located at 4544 through 4550 South Puget Sound Avenue in the Tacoma Mall Mixed-Use Center.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36480

Authorizing the execution of an agreement with Development Counsellors International, in the amount of \$104,000, to provide economic development marketing services to promote Tacoma for business expansion, attraction, and retention, through December 31, 2006.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36481

Approving a total project budget in the amount of \$89 million for the Central Treatment Plant Upgrade and Expansion Project; authorizing the execution of a Design-Build agreement with Montgomery Watson Harza, in the amount of \$79 million, for the design and construction of said project; and designating said project as a "Special Project of Limited Duration."

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36482

Authorizing the execution of a collective bargaining agreement negotiated with the Tacoma Police Union, Local 6, I.U.P.A., which currently covers 323 employees, effective January 1, 2004, through December 31, 2004.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

Resolution No. 36483

Authorizing the execution of Amendment No. 2 to the Agreement with Keating, Bucklin & McCormack, Inc., P.S., in the amount of \$175,000, for a cumulative total of \$200,000; and the execution of Amendment No. 1 to the Agreement with McGavick Graves, P.S., in the amount of \$175,000, for a cumulative total of \$200,000, for legal services in the matter of Robert R. Blystone and Carla Blystone v. Joseph Bundy and Pamela Rush v. City of Tacoma, United States District Court of Washington, Cause No. C04-5535 FDB.

Deputy Mayor Ladenburg moved that the Resolution be adopted. Seconded by Council Member Phelps. Voice vote was taken and carried. The Resolution was declared adopted.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Deputy Mayor Ladenburg recognized Mr. Tom Hillyard, Director of Community Services, Pierce County, who has been very involved in the Alliance for Youth Program. She stated Mr. Hillyard has been actively promoting the "County and City of Promise" program.

Council Member Evans recognized former City Manager Erling Mork. He invited the public to attend the lighting of a gas lamp which will be lit in Mr. Mork's honor at 7th and Commerce Streets.

Council Member Lonergan commented on a previous discussion regarding the Historically Underutilized-Business program during last week's Council meeting. He reported ADP Construction has been selected to perform the electrical work for the Proctor Street Bridge project. He congratulated the Finance Department for receiving the Certificate of Excellence for Finance Reporting, the highest recognition a City can achieve. He mentioned two of Tacoma's hospitals were recognized as being among the 100 best healthcare networks in the nation. He concluded by congratulating the Tacoma Housing Authority for completing the refurbishing of the EB Wilson Apartments located at South 12th and South M Streets.

Mayor Baarsma invited the public attend a Tacoma Rainiers baseball game.

Deputy Mayor Ladenburg moved to excuse Council Member Anderson from tonight's meeting. Seconded by Council Member Talbert. Voice vote was taken and carried. The motion was declared adopted.

Mayor Baarsma moved to convene to Executive Session to evaluate the qualifications of the candidates for the City Manager's position, the session not to exceed 60 minutes. Seconded by Deputy Mayor Ladenburg. Voice vote was taken and carried. The motion was declared adopted.

Council convened to Executive Session at 6:50 p.m. Mayor Baarsma extended the session for an additional 30 minutes at 7:50 p.m. Mayor Baarsma extended the session for another 30 minutes at 8:20 p.m. The Council reconvened at 8:46 p.m.
