Authorizing the execution of an Interlocal Cooperation Agreement with Pierce County in the amount of \$31,196.66 to finance and administer the design and implementation of energy conservation improvements in the County-City Building.

Mayor Sutherland moved that the Resolution be adopted. Seconded by Council Member Warnick. Voice vote was taken and carried with Deputy Mayor Rasmussen abstaining. The Resolution was declared adopted.

Resolution No. 29510

Designating certain Arterial Street Projects as Major Independent Construction Projects and establishing the salaries, classes, fringe benefits and compensation for project positions.

Council Member Nielsen moved that the Resolution be adopted. Seconded by Council Member Harnick.

Council Member Mykland moved that the Resolution be continued for one week. Seconded by Council Member Moss. Voice vote was taken and carried. The Resolution was continued to the Council meeting of March 3, 1987.

Resolution No. 29511

Designating the Storm Water Quality Project as a Major Independent Construction Project and establishing the salaries, classes, fringe benefits and compensation for project positions.

Council Member Mykland moved that the Resolution be continued for one week. Seconded by Council Member Hyde. Voice vote was taken and carried. The Resolution was continued to the Council meeting of March 3, 1987.

Resolution No. 29512

Authorizing the execution of an agreement with the Department of Public Utilities relative to the establishment of the Commercial Incentive Pilot Program for the Park Plaza North and Park Plaza South parking structures.

Deputy Mayor Rasmussen moved that the Resolution be adopted. Seconded by Council Member Mykland. Voice vote was taken and carried. The Resolution was declared adopted.

PUBLIC HEARINGS AND APPEALS: (Began at 6:00 p.m.)

This is the date set for hearing the appeal of Capitol Center, Inc. of the decision of the Hearings Examiner relative to a determination as to whether or not there are parking restrictions which would prohibit or inhibit additional office space or retail space at the Tacoma Mall office building site located east of South Pine Street between South 43rd and 45th Streets extended (File No. 85.13).

Council Member Mykland stated that he had participated in some of the parking reductions around the Tacoma Mall area regarding his position at Pierce Transit and was well aware of what's going on with the parking issues in that area. He did not feel this had biased his opinions or decisions or anything else and that he could make a fair and reasonable judgment. He stated that if there was any objection to his hearing this case, then he would leave the room. No objections were voiced, and Council Member Mykland sat in on the hearing.

Rodney Kerslake, Hearings Examiner, made a presentation to the Council regarding the appeal.

Bill F. Lynn, Attorney representing Capitol Center, Inc., gave the reasons for the appeal.

Craig Hentz, representing the Tacoma Mail Corporation, spoke in support of the Hearings Examiner's decision.

Deputy Mayor Rasmussen moved to concur in the findings, Conclusions and Recommendations of the Hearings Examiner and deny the appeal. Seconded by Council Member Nielsen.
