REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz, Jr. introduced Diane Supler, who began yesterday as the new Director of Budget, Management and Analysis. He mentioned a reception was held yesterday in her honor.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Moss thanked the Council for allowing her to participate in Washington, D.C., at the National League of Cities Conference. She presented the 2001 Action Agenda, which has been named "Investing in Communities." She stated the six action items including: reducing poverty; revitalizing existing communities and neighborhoods; investing in the infrastructure; investing in families, children and youth; supporting local government and minimizing fiscal challenges, and promoting justice and equal opportunities. She stated the National League of Cities strongly urged the



President to enact about a detailed 10-year budget before acting on tax cuts. She stated there was real concern that this has been a practice in the past. She concluded by mentioning that she has information for the Council regarding national priorities.

Council Member McGavick stated she met last week with the Cross-District Committee, of our business districts, and that they have many significant needs. She suggested a meeting with the Mayor and Council Members to obtain permanent funding in the budget for their coordinators. She stated she had informed them of the budget situation of the City and that they would be up against many competitors in the budgeting process. She also suggested to them that they contact the Economic Development Board.

Council Member Miller stated he also had attended the National League of Cities congressional meeting last week. He stated he participated in workshops and leadership training to improve his skills as an elected official. He stated they heard from cabinet members regarding their priorities. He listened to Transportation Secretary Minetta; Housing and Human Services Secretary; and HUD Secretary Martinez, as well as Attorney General John Ashcroft. He stated the Attorney General emphasized his priorities are to bring an end to racial profiling and to ensure better access to our polling places across the country. He stated they also heard from Senators Joseph Lieberman and John Carry about their city priorities. He stated they finished with a meeting on Capital Hill with Congressman Dicks and had a chance to have a good, one-on-one with him and put forth some of the City's priorities for federal funds and grants.

Council Member De Forrest stated he was at the Eastside Neighborhood Council meeting last night and was shocked to find out that the Park District does not plan to open the South End Swimming Pool this year. He stated Titlow would be open, but not the South End Pool. He stated it was not open last year because of budget problems and now they have found a water leak, which may cost \$1 million to repair. He asked for a report from staff. He stated the pool was actually within Council Member Scarbrough's district and hoped that she could contact someone from the Park District. Council Member De Forrest reminded City Manager Corpuz that when the Employment Security Building was located on Portland Avenue, the intent was to install a signal light, crosswalk and a handicap ramp. He stated that construction of the handicap ramp has not been completed.

Deputy Mayor Phelps moved to excuse Council Member Evans from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Mayor Crowley announced there would be a special meeting of the City Council on Monday, March 26, 2001, at 5 p.m., in Room 16, of the Tacoma Municipal Building North, 733 Market Street. This meeting will provide public input on a potential Capital Improvement Bond measure, which could be placed on the May 2001 ballot, to fund construction of the police headquarters, renovations to the Tacoma Dome and Cheney Stadium, improvements to the Pantages Theater, Housing Trust Fund and other neighborhood enhancement projects. He stated Council Member McGavick would chair the meeting.

On proper motion, the meeting was adjourned at 7:37 p.m.
