COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Kirby commented on the Cortex Research and Development Association's conference that was held at the Landmarks Convention Center.

Deputy Mayor Baarsma reported that the University of Puget Sound and the Pacific Lutheran University will be hosting the National Association of Intercollegiate Athletics Swimming Championships. He stated that the University of Puget Sound's men and women are the defending champions. He stated that the swimming championships will be held in Federal Way and that over 300 people would be competing in this event. Deputy Mayor Baarsma then stated he would be making the opening remarks at the swimming championships.

Council Member Miller asked Council Members and citizens to support the Bill that is before the State Legislature that addresses the "joint and several liability" issue. He stated that the City of Tacoma continues to pay out large sums of money out of the fear of being found one percent liable because of a signage question, striping or design in the street, and that the City will be looked at to pay the entire amount because usually the defendants are judgment-proof. He stated that this Bill would remove that requirement. Council Member Miller made complimentary comments regarding the article on crime in the latest issue of *The New Takhoman*.

Council Member Silas asked Randy Lewis, Government Relations, about the Welfare Reform Bill.

Mr. Randy Lewis, Government Relations, gave an overview of the Welfare Reform Bill.

Mayor Ebersole asked citizens to contact their Legislator and let them know how important it is for Tacoma and the South Sound Region to get funding for the University of Washington Tacoma Campus.

Council Member Evans commented on some of the concerns that Senator Wojahn has regarding representation from Pierce County at the hearings concerning either trauma or the Welfare Reform Bill.

Mayor Ebersole stated this was a good point and that there are many opportunities where City Council Members can appear before Legislative committees on a variety of issues that impact the City of Tacoma. He asked Randy Lewis, Government Relations, to keep the City Council posted for times they could go down and help make an appearance.
