Discussion was held regarding the possibility of having a H.U.D. staff member attend that meeting for purposes of discussing these issues.

Mayor Sutherland requested that the Council Workshop originally scheduled for May 19 be rescheduled.

Mayor Sutherland requested that staff investigate the pedestrian problem at the Tacoma Dome.
