# COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL:

Mayor Sutherland noted that certain dates during the summer were available for possible cancellation of Council meetings by the Tacoma City Council. He stated that there were no public hearings or appeals scheduled for July 21, July 28, August 18, and August 25, 1987, and recommended that the Council look at their schedule for possible meeting cancellations.

Council Member Warnick stated that September 8, 1987, the Tuesday following Labor Day, might be a possible date for cancellation.

Mayor Sutherland requested information from the City Clerk's Office on the possibility of cancellation of the September 8, 1987 Council meeting.

Council Member Mykland moved to excuse Council Members Hyde, Moss, Rasmussen, and Stenger from the Council meeting of June 23, 1987. Seconded by Council Member Nielsen. Voice vote was taken and carried. The motion was declared adopted.

Mayor Sutherland stated that the Tacoma City Charter, Section 2.10, requires that every ordinance and resolution have an affirmative vote of at least five ayes for passage. He stated therefore that Resolution No. 29656, thereby was declared failed and not declared adopted.

Mayor Sutherland instructed the City Clerk to bring Resolution No. 29656 before the Council in next week's Agenda.

Mayor Sutherland also stated that the City Clerk should bring Ordinance No. 23870 before the City Council on next week's Agenda also.

Mayor Sutherland stated that Ms. Darina Reynolds had won a day with the Mayor as a result of the City Hall at the Hall drawing, and indicated that the City Clerk would notify Ms. Reynolds of her winning and would coordinate the activities.
