REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. stated that the City of Tacoma has met with representatives from Kaiser Aluminum regarding the strike at Kaiser Aluminum. He stated that the City of Tacoma has encouraged the plant manager to work for a quick resolution. He stated that the City of Tacoma is concerned over the health and safety issues that surround that site. Mr. Corpuz stated that representatives of Kaiser Aluminum will be advising the City of Tacoma of the status of any outstanding issues. He stated that the City Attorney's Office is looking at Chapter 8.98 of the Municipal Code regarding Professional Strikebreakers and will be getting back to the City Council with an answer on that issue.

City Manager Corpuz noted that one of the visions of the City is to become an international city known for our multicultural population. He stated the City Manager's Office has begun meeting informally with different ethnic groups throughout the city. He stated that the purpose of these meetings is to find out their needs, to open the lines of communication, to create a better understanding of our administration and how the City might improve on addressing their specific needs. He stated that he will continue to report on these meetings as they take place.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Council Member Baarsma moved to excuse Mayor Ebersole from tonight's meeting. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

He stated that she was active in the Democratic Party and with City Council elections. Council Member McGavick thanked the Police Department for checking on a reported crack house on the Eastside of Tacoma.
