REPORTS BY CITY MANAGER

City Manager Ray E. Corpuz Jr. stated that the City of Tacoma received good news from the Interagency for Outdoor Recreation (IAC) for the Wapato Hills project. He then congratulated the Wapato Hills Task Force and staff from the Metropolitan Park District, as well as our own staff, for all of their hard work. Mr. Corpuz announced that the City of Tacoma will have almost \$2 million for the project.

Mr. Corpuz stated that there are a number of study sessions regarding Municipal Code issues being scheduled. Mr. Corpuz stated that the issues included: sign posting, single-family dwelling units and dormitories, and the Municipal Code and how it is applied and enforced.

Mr. Corpuz then corrected his report on being gone this week. He stated that he would be in the office through Wednesday.

COMMENTS AND COMMITTEE REPORTS OF CITY COUNCIL

Acting Mayor Evans congratulated all those who were involved with the work that went into getting the \$2 million for the Wapato Hills project. He stated it was a major achievement.

Acting Mayor Evans then noted the passing of Mary Baker Russell. He stated that she was a very quiet person with enormous impact on our City and region. He stated she was a benevolent benefactress of Mary Bridge Children's Hospital, an orphanage in Sri Lanka, and the Mary Baker Russell Music Pavilion at Pacific Lutheran University. Acting Mayor Evans stated that she was generous. He stated that she had worked in the Mary Bridge Print Shop, had sewed baby garments in the basement, and had worn \$5 shoes when she did it. He stated she was a remarkable woman with a remarkable family. He stated that this City and region owe her a great debt and that she will be missed.

City Manager Ray E. Corpuz Jr., requested that the City Council consider a residency waiver. He then called on Mr. Jan Gilbertson, Human Resources Director, for background information on the request for residency waiver.

Council Member De Forrest moved to grant the waiver of residence for Mr. Dean Mazur as requested by Jan Gilbertson, Human Resources Director. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

Council Member Crowley moved to cancel the City Council meeting of Tuesday, September 2, 1997. Seconded by Council Member McGavick. Voice vote was taken and carried. The motion was declared adopted.

Council Member McGavick moved to excuse the absence of Council Members Baarsma and Miller and Mayor Ebersole from tonight's meeting. Seconded by Council Member Crowley. Voice vote was taken and carried. The motion was declared adopted.

Council Member Kirby stated he had a letter addressed to the Mayor, Council and City Manager. He stated that the letter had to do with the people who live next door to Fire Station No. 10, where there was some landscape work being done by the Public Works Department. He stated that apparently the Public Works Department sprayed some Round-up, which oversprayed onto the neighbor's property. He then requested that this issue be resolved.

Council Member De Forrest thanked Bill Pugh, Public Works Director, and Gary Pedersen, Manager of the Building and Land Use Division, for taking action on the land use issues in East Tacoma that were brought to the attention of the City Council under Citizens' Forum this month.

Council Member De Forrest then stated that he is looking forward to having a 24-hour police station in Sector 4 in the near future.
